I..UNITED STATES ARMY WAR COLLEGE, CARLISLE BARRACKS, PENNSYLVANIA. *Effective 1 July 1960*, the United States Army War College is established as a class II activity under the jurisdiction of the Deputy Chief of Staff for Military Operations, at Carlisle Barracks, Pennsylvania, a class I installation under the jurisdiction of the Commanding General, Second United States Army.

II..PHILADELPHIA QUARTERMASTER DEPOT, PENNSYLVANIA. *Effective 1 July 1960*, the Philadelphia Quartermaster Depot, Pennsylvania, a class II installation under the jurisdiction of The Quartermaster General, is redesignated the Philadelphia Quartermaster Center, U.S. Army.

III..ST. LOUIS CHEMICAL PLANT, MISSOURI. *Effective 28 April 1960*, the St. Louis Chemical Plant, Missouri, a class II industrial installation under the jurisdiction of the Chief Chemical Officer, is discontinued as a Department of the Army installation.

IV..WEST VIRGINIA ORDNANCE WORKS, WEST VIRGINIA. *Effective 5 April 1960*, the West Virginia Ordnance Works, West Virginia, a class II industrial installation under the jurisdiction of the Chief of Ordnance, is discontinued as a Department of the Army installation.

V..NATIONAL BOARD FOR PROMOTION OF RIFLE PRACTICE. *Effective 5 July 1960*, Major General Louis W. Truman, USA, Deputy Chief of Staff for Operations Plans and Training, USCONARC, is announced as a member of the National Board for the Promotion of Rifle Practice, serving as Vice-Chairman of the Executive Committee and as a member of the Budget Committee, representing Headquarters, United States Continental Army Command, vice Major General Den Harrell, reassigned, effective 1 June 1960.
