I..WARRIOR OF THE PACIFIC TEAM COMPETITION. 1. In accordance with paragraph 10, AR 145-305, the annual Warrior of the Pacific rifle competition was conducted at General Military Science ROTC training camps. Arizona State University, Tempe, Arizona, is announced as the winner of the Warrior of the Pacific trophy for the year 1960. Average score per man was 190.36.

2. The Commanding General, Sixth United States Army, will make necessary arrangements for shipping the statuette, the "Warrior of the Pacific Trophy," now in the possession of Oregon State College, Corvallis, Oregon.
