**I..FORK POLK, LOUISIANA.** *Effective 25 August 1961*, Fort Polk, Louisiana, a class I installation under the jurisdiction of the Commanding General, Fourth United States Army, is placed in an active status.

**II..CAMP IRWIN, CALIFORNIA.** *Effective 1 August 1961*, Camp Irwin, California, is redesignated Fort Irwin, California, and announced as a permanent Department of the Army installation.

**III..CHICAGO ADMINISTRATION CENTER, ILLINOIS.** *Effective 1 July 1961*, the Chicago Administration Center, 1819 West Pershing Road, Chicago, Illinois, a class II installation under the jurisdiction of The Quartermaster General, was discontinued as a Department of the Army installation.

**IV..ST. LOUIS AREA SUPPORT CENTER, MISSOURI.** *Effective 1 July 1961*, the St. Louis Area Support Center, 12th and Spruce Streets, St. Louis, Missouri, a class I installation under the jurisdiction of the Commanding General, Fifth United States Army, was discontinued as a Department of the Army installation.

**V..THE UNITED STATES ARMY TRAINING CENTER, FORT CARSON, COLORADO.** Section I, General Orders 20, 1961, is amended to delete the word "Infantry" from the designation of the U.S. Army Training Center, Fort Carson, Colorado.

**VI..FIELD DIVISION, OFFICE CHIEF OF FINANCE, U.S. ARMY, FORT BENJAMIN HARRISON, INDIANA.** *Effective 1 October 1961*, the Field Division, Office Chief of Finance, U.S. Army, a class II activity under the jurisdiction of the Chief of Finance, located at Fort Benjamin Harrison, Indiana, is discontinued and its functions assigned to other activities. The training functions will be performed by the Finance School, U.S. Army, and all other functions will be performed by the Finance Center, U.S. Army, both class II activities under the jurisdiction of the Chief of Finance, located at Fort Benjamin Harrison, Indiana.
