**I. GENERAL COURTS-MARTIAL.** The Commanding Officer, United States Army Element, Headquarters U.S. STRIKE Command, MacDill Air Force Base, Florida, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial, effective 8 February 1962.

**II. CAMP A. P. HILL, VIRGINIA.** Effective 31 March 1962, Camp A. P. Hill, Virginia, a class I installation under the jurisdiction of the Commanding General, Second United States Army is placed in an inactive status.

**III. SCHUYLKILL ARSENAL, PENNSYLVANIA.** Effective 20 November 1961, Schuykill Arsenal, Philadelphia, Pennsylvania, a class I installation under the jurisdiction of the Commanding General, Second United States Army, was discontinued as a Department of the Army installation.

**IV. OKLAHOMA ORDNANCE WORKS, OKLAHOMA.** Effective 17 October 1961, Oklahoma Ordnance Works, Pryor, Oklahoma, a class II industrial installation under the jurisdiction of the Chief of Ordnance, was discontinued as a Department of the Army installation.

**V. MAUMELLE ORDNANCE WORKS, ARKANSAS.** Effective 25 May 1961, Maumelle Ordnance Works, Little Rock, Arkansas, a class II industrial installation under the jurisdiction of the Chief of Ordnance, was discontinued as a Department of the Army installation.
