I. U.S. ARMY ELEMENT, DEFENSE RESEARCH OFFICE, LATIN AMERICA (9986). *Effective 1 July 1962*, the U.S. Army Element, Defense Research Office, Latin America (9986) is organized as a class II activity under the command of the Chief of Research and Development with station at Rio de Janeiro, Brazil.

II. U.S. ARMY CHEMICAL-BIOLOGICAL-RADIOLOGICAL COMBAT DEVELOPMENTS AGENCY. *Effective 1 June 1962*, the U.S. Army Chemical Corps Board at Army Chemical Center, Maryland, and the U.S. Army Chemical Corps Field Requirements Agency at Fort McClellan, Alabama, both class II activities under the jurisdiction of the Chief Chemical Officer, are consolidated at Fort McClellan, Alabama, and redesignated the U.S. Army Chemical-Biological-Radiological Combat Developments Agency, a class II activity under the jurisdiction of the Chief Chemical Officer.

III. QUARTERMASTER BOARD, U.S. ARMY, FORT LEE, VIRGINIA. *Effective 1 May 1962*, the Quartermaster Board, a class II activity under the jurisdiction of The Quartermaster General, at Fort Lee, Virginia, is redesignated the U.S. Army Quartermaster Combat Developments Agency.

IV. DESERET TEST CENTER, UTAH. *Effective 1 May 1962*, the Deseret Test Center is established at Salt Lake City, Utah, as a class II activity under the jurisdiction of the Chief Chemical Officer.
