III. SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to Private First Class *Robert L. McBride*, RA19631770, United States Army, a member of the United States Army Garrison and Technical Services, Antilles, Fort Buchanan, Puerto Rico, distinguished himself by heroism in rescuing an individual from drowning on 11 March 1962, at Punta Maldonado, Puerto Rico.

while swimming in the safety of near-shore waters, Private *McBride* noticed that another person swimming in the area was being rapidly carried to sea by a strong undercurrent despite this individual's ability as a qualified swimmer and his physical efforts to resist the strong tide and rough water. Without hesitation, and despite personal safety and danger of himself being caught by the strong undercurrent and tide, Private *McBride* plunged into the surf and swam to the aid of the distressed person. He then rendered immediate assistance and exerted extraordinary physical efforts in towing the then exhausted swimmer approximately 100 yards to a point of safety. Private *McBride's* heroic act, with complete disregard of personal safety, consummate courage, and calm demeanor throughout this incident, resulted in the saving of a human life, and reflects the highest credit on himself and the United States Army.
