III. DISTINGUISHED UNIT CITATION.

As authorized by Executive Order 9396 (Sec. I, WD Bul. 22, 1943), superseding Executive Order 9075 (Sec. III, WD Bul. 11, 1942), citation of the following unit in the general orders indicated is confirmed in accordance with paragraph 194, AR 672-5-1 in the name of the President of the United States as public evidence of deserved honor and distinction. The citation reads as follows:

Company "A" of the 802d Engineer Aviation Battalion is cited for extraordinary heroism and distinguished service during the period 12 July to 26 August 1950. This company was detached from its parent organization and moved to Pohang, Korea, on 12 July 1950, where it was given

the mission of repairing and extending the airstrip which was in imminent danger of enemy air and ground attack. Despite this danger of attack and the hazards of constructing an airstrip while it was in constant use as an advance base, the men of Company "A" of the 802d Engineer Aviation Battalion worked tirelessly to complete their work. Elements of this unit engaged the enemy continuously for one and one half days in defense of the strip. Only when it was surrounded and under full attack was the company evacuated by LSP to Pusan, Korea, where it was immediately committed in the construction of the East Pusan airstrip on 14 August 1950. The achievements of Company "A" of the 802d Engineer Aviation Battalion throughout this period were in keeping with the highest traditions of the service, and reflected great credit upon itself, the Far East Air Force, and the United States Air Force.
