I.—GENERAL COURTS-MARTIAL. The Commanding Officer, 2d Logistical Command, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial, *effective 24 October 1962.*

II.—GENERAL COURTS-MARTIAL. The Commanding Officer, U.S. Army Test and Evaluation Command, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial, *effective 24 October 1962.*

III.—DEFENSE LANGUAGE INSTITUTE. 1. *Effective 5 November 1962*, the Defense Language Institute (short title "DLI") is established as a class II activity under the jurisdiction of the Deputy Chief of Staff for Military Operations, Headquarters, Department of the Army, with headquarters at Washington, D.C.

2. The Defense Language Institute will be administered by the Department of the Army in accordance with the authority and general policies set forth in Department of Defense Directive 5160.41, October 19, 1962, except as they may from time to time be modified with the approval of the Secretary of Defense.

3. The mission of the Defense Language Institute is to exercise technical control of all language training within the Defense Establishment (except at the Service Academies) and to direct those elements of the program which are conducted on a Department of Defense-wide basis by the Department of the Army.

4. On or about 1 July 1963, the United States Army Language School, Presidio of Monterey, California, will be discontinued as a class I activity under the jurisdiction of the Commanding General, Sixth United States Army, and its assigned functions, personnel, funds and facilities will be transferred to the Defense Language Institute. Similarly, the Language Department of the Naval Intelligence School, Washington, D.C., and appropriate foreign language training elements of the Department of the Air Force will be transferred to the Defense Language Institute.

IV.—U.S. ARMY INTELLIGENCE BOARD. *Effective 30 September 1962*, the U.S. Army Intelligence Board, an activity of the U.S. Army Intelligence Center, is discontinued.
