**I. DEPOT ACTIVITIES.** *Effective 1 August 1962*, the following depot activities, all class II activities, under the jurisdiction of the Commanding General, U.S. Army Materiel Command, are discontinued. Functions, personnel, and equipment are integrated with the installation concerned, each of which is a class II installation under the jurisdiction of the Commanding General, U.S. Army Materiel Command:

**II. ROCK ISLAND DEPOT ACTIVITY.** *Effective 1 January 1963*, the Rock Island Depot Activity, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, located at Rock Island Arsenal, Rock Island, Illinois, a class II installation under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is discontinued. Functions, personnel, and equipment are consolidated with the Rock Island Arsenal.

**III. UNITED STATES ARMY NUCLEAR WEAPONS SYSTEMS SAFETY GROUP.** *Effective 31 October 1962*, the U.S. Army Nuclear Weapon Coordination Group, Washington 25, D.C., a class II activity under the Deputy Chief of Staff for Military Operations, is redesignated as the U.S. Army Nuclear Weapons Systems Safety Group.
