IV--SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Captain *Max J. Wilson*, O84897, Armor, United States Army, a member of Headquarters Company, 4th Armored Division, United States Forces, Europe, distinguished himself by heroism on 11 April 1962, near Rimbach, Germany. When Captain *Wilson* detected an Ordnance Battalion tent on fire in the middle of the night, he rushed to the tent giving the alarm on the way. Although he was handicapped by a painful ankle caused by a previous injury, he unhesitatingly and with complete disregard for his own personal safety, entered the burning tent to search for sleeping occupants. While flaming debris was falling about and the tent was in a state of impending collapse and contained the fuel tank of the tent stove, Captain *Wilson* fought the

intense smoke fumes, unzipped sleeping bags to insure that there were no occupants, and continued his diligent search until he was assured that the tent was unoccupied. Captain *Wilson's* courageous action in this emergency reflects great credit on himself and the military service. (This award supersedes the previous award of the Army Commendation Medal to Captain *Wilson* for meritorious achievement on 11 April 1962 as announced in General Orders No. 74, Headquarters 4th Armored Division, 28 July 1962.)

V--BRONZE STAR MEDAL. By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal for meritorious service in connection with military operations against hostile forces is awarded posthumously to:

VII--BRONZE STAR MEDAL. 1. By direction of the President, under the provisions of Executive Order 9419, 4 February 1944, a Bronze Star Medal with "V" device (First Oak Leaf Cluster) for heroic achievement in connection with military operations against an enemy of the United States is awarded to:

Captain *Walter E. Klepadlo*, O2097136 (then First Lieutenant), Infantry, United States Army, while serving with Company "C," 23d Infantry Regiment, 2d Infantry Division, distinguished himself by heroic achievement during ground combat against an armed enemy on 16 July 1953, in the vicinity of Ansan, North Korea. While performing a mission of laying trip flares in front of the positions of Outpost "Harry," Captain *Klepadlo* and his five man detail were suddenly subjected to intense enemy mortar and small arms fire. Realizing there would be no advantage in making a stand because of the size and exposed position of his group, he directed his men to return to the Outpost. Exposing himself to enemy fire, Captain *Klepadlo* covered the withdrawal of his men with his weapon and checked to see that no one was left behind. Only when he was satisfied that the group had reached the Outpost did he leave his position. By his calm, decisive action in this hazardous situation, the group was able to withdraw in an orderly manner and casualties were averted. Captain *Klepadlo's* heroic action reflects great credit on himself and the military service.
