**I. DISTINGUISHED SERVICE CROSS.** By direction of the President, under the provisions of the Act of Congress approved, 9 July 1918, the Distinguished Service Cross for extraordinary heroism in action against an enemy is awarded to:

Master Sergeant *Lee E. Copeland*, RA15203196, (then Corporal), United States Army, while a member of the 1st Battalion, 8th Cavalry Regiment, distinguished himself by extraordinary heroism in connection with military operations against an armed enemy on 22 July 1950, in the vicinity of Yong-dong, Korea. When an enemy force of great strength launched a fanatical banzai attack against the 1st Battalion, Sergeant *Copeland* displayed great initiative and unfaltering fortitude as a platoon gunner. While his platoon withdrew to better ground, he held his position and started firing his machine gun into enemy forces. As the enemy turned artillery and mortar fire upon him, he dashed from spot to spot carrying his machine gun, stopping in each new position to fire his carbine and toss grenades while waiting for the machine gun barrel to cool sufficiently to resume firing. Sergeant *Copeland's* effectiveness and heroic action enabled the platoon time to withdraw and set up a new defense. He then fought his way back into the Company perimeter where he continued to lend supporting fire and helped to organize the defense during the 5-hour grueling attack. His leadership, courage, and exemplary conduct were an inspiration to the members of the Company and spurred them to victory despite the overwhelming disadvantages. Sergeant *Copeland's* outstanding performance and heroic action reflect great credit upon himself and the military service.

**II. DISTINGUISHED SERVICE MEDAL.** By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, the Distinguished Service Medal for exceptionally meritorious and distinguished service in a position of great responsibility is awarded to:

10600, 15 March 1955, the Legion of Merit for exceptionally meritorious conduct in the performance of outstanding service is awarded posthumously to:

Major *Joseph A. Fontana*, O60439, Corps of Engineers, United States Army. August 1961 to August 1962.

(This award supersedes award of the Army Commendation Medal for meritorious service from 14 July 1954 to 21 June 1957 as announced in General Orders Number 30, Headquarters, U.S. Army Ordnance Corps, Redstone Arsenal, dated 21 June 1957 and award of the Army Commendation Medal (First Oak Leaf Cluster) for meritorious service from 19 August 1957 to 11 October 1958 as announced in General Orders Number 250, Headquarters, U.S. Army Advisory Group, Korea, dated 9 October 1958.)

Colonel *Walter E. Lotz, Jr.*, O21090, Signal Corps, United States Army. August 1959 to August 1962.

Colonel *Richard L. McKee*, O19453, General Staff (Artillery), United States Army. June 1953 to December 1962. (This award supersedes award of the Army Commendation Medal (First Oak Leaf Cluster) for meritorious service from August 1959 to May 1961, as announced in General Orders Number 20, Headquarters Military Assistance Advisory Group, Republic of China, dated 16 May 1961.)

Brigadier General *William M. Rodgers*, O39812, United States Army. February 1962 to January 1963.

3. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the

Legion of Merit (Second Oak Leaf Cluster) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

Lieutenant General *Hamilton H. Howze*, O18088, United States Army. October to November 1962.

**V. LEGION OF MERIT.** 1. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Commander) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

Air Chief Marshal *Dawee Chullasapya*, DH 340/2476, Royal Thai Air Force. October 1961 to October 1962.

2. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Officer) (Second Award) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

Lieutenant General *Mozzafar Malek*, Imperial Iranian Gendarmerie. March 1961 to September 1962.

3. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Legionnaire) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

Brigadier General *Francois L. E. Marchand*, 2544103264, National Army of the Republic of France. March 1952 to July 1962.

**VI. DISTINGUISHED FLYING CROSS.** By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Distinguished Flying Cross for heroism while participating in aerial flight is awarded by the Department of the Army to:

First Lieutenant *William H. Hinds*, O5203982, Transportation Corps, United States Army, 57th Transportation Company (Light Helicopter), distinguished himself by heroism while participating in aerial flight on 23 March 1962, in the vicinity of Mekong River Delta Area, Vietnam. As a pilot of an H-21 helicopter, Lieutenant *Hinds* was participating in a combat support mission when another helicopter involved in the mission suffered an engine failure in the midst of a fire fight. The disabled aircraft was downed in hostile territory and subjected to intense ground fire. With complete disregard for his own personal safety, Lieutenant *Hinds* unhesitatingly and skillfully landed the aircraft beside the stricken helicopter and quickly evacuated the crew members. When it was later discovered that the crew chief of the downed aircraft had not boarded the rescue craft and was still in the contested zone, he immediately returned to the area, which was still under fire, to rescue the stranded crew member. Lieutenant *Hinds'* sound judgment, professional competence, and outstanding performance of duty in the face of grave danger reflect great credit upon himself and the military service.

Chief Warrant Officer *Billy J. Williams*, W2205457, United States Army, 57th Transportation Company (Light Helicopter), distinguished himself by heroism while participating in aerial flight on 23 March 1962, in the vicinity of Mekong River Delta Area, Vietnam. As a co-pilot of an H-21 helicopter, Chief Warrant Officer *Williams* was participating in a combat support mission when another helicopter involved in the mission suffered an engine failure in the midst of a fire fight. The disabled aircraft was downed in hostile

territory and subjected to intense ground fire. With complete disregard for his own personal safety, Chief Warrant Officer *Williams* unhesitatingly and skillfully landed the aircraft beside the stricken helicopter and quickly evacuated the crew members. When it was later discovered that the crew chief of the downed aircraft had not boarded the rescue craft and was still in the contested zone, he immediately returned to the area, which was still under fire, to rescue the stranded crew member. Chief Warrant Officer *Williams'* sound judgment professional competence and outstanding performance of duty in the face of grave danger reflect great credit upon himself and the military service.

**VII. SOLDIER'S MEDAL.** By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded posthumously to:

Private *Eurvee Jackson, Jr.*, RA16733348, Transportation Corps, United States Army, Company C, 17th Transportation Battalion, 7th Infantry Division, distinguished himself by heroism on 12 September 1962, in Korea. Private *Jackson* was participating in an armored personnel carrier driver training exercise when the amphibious vehicle he was driving was caught in the rapid current of the Hantan River. As the vehicle was swept downstream and struck a rock, a fellow soldier was thrown into the treacherous river. Knowing that the soldier could not swim, Private *Jackson* immediately, and with complete disregard for his own personal safety, jumped out of the driver's hatch and into the river to aid him. In his attempt to rescue his comrade, he was caught in the strong current and disappeared beneath the water. Private *Jackson's* courageous act of self-sacrifice is in the highest traditions of the United States Army and reflects great credit upon himself and the military service.

**VIII. SOLDIER'S MEDAL.** By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Specialist Five *Harold V. Haubrich*, RA16301314, United States Army, while serving as a Senior Aidman, Company B, 1st Battle Group, 23d Infantry, Fort Richardson, Alaska, distinguished himself by heroism on 27 March 1962 in the vicinity of Campbell Pass, Alaska. Specialist *Haubrich* was on a routine cross country field training exercise over rugged and hazardous terrain covered with several feet of snow when the lead sergeant of the trail breaking party was suddenly caught in a snow avalanche which carried him down the side of a mountain and buried him under heavy snow. Without hesitation or regard for his own life, and despite the warnings of another member of the party, Specialist *Haubrich*, laden with skis, rucksack, and field gear, swiftly jumped into the snow slide to assist the trapped sergeant. This rapid action enabled him to retain sight of the sergeant, who, with the exception of one hand, was buried completely under the snow and unable to move either of his arms when the slide subsided. He then quickly and persistently dug a 2½-foot passage to the victim's face and cleared the throat which was packed with snow to prevent suffocation. After much difficulty in digging the sergeant out of the snow, he rendered first aid treatment and accompanied him until he was out of danger. Specialist *Haubrich's* initia-

tive, perserverance, and courageous and prompt action in the dangerous feat reflect great credit upon himself and the military service.

**IX--AIR MEDAL.** By direction of the President, under the provisions of Executive Order 9158, 11 May 1942, has amended by Executive Order 9242-A, 11 September 1942, an Air Medal for meritorious achievement while participating in aerial flight is awarded by the Department of the Army to:

Chief Warrant Officer *William K. Carmical*, W2149429, United States Army. November 1961 to January 1962.
