**I.—U.S. ARMY AVIATION BOARD.** *Effective 1 December 1962*, the U.S. Army Aviation Board, Fort Rucker, Alabama, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is redesignated the U.S. Army Aviation Test Board, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command.

**II.—U.S. AIRCRAFT TEST AND SUPPORT ACTIVITY.** *Effective 1 December 1962*, the U.S. Army Transportation Aircraft Test and Support Activity, Fort Rucker, Alabama, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is discontinued. Its functions, personnel, records, and equipment are transferred to the U.S. Army Aviation Test Board.

**III.—U.S. ARMY ARCTIC TEST BOARD.** *Effective 8 November 1962*, the class II activities listed below, all under the jurisdiction of the Commanding General, U.S. Army Materiel Command, are discontinued, and functions, personnel, records, and equipment transferred to the U.S. Army Arctic Test Board, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, at Fort Greely, Alaska.

**IV.—U.S. ARMY MATERIEL COMMAND SUPPORT ACTIVITY.** *Effective 1 December 1962*, the U.S. Army Materiel Command Support Activity, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, at Cameron Station, Virginia, is discontinued.

**V.—U.S. ARMY MILITARY ASSISTANCE PROGRAM LOGISTICS AGENCY.** *Effective 1 February 1963*, the U.S. Army Military Assistance Program Logistics Agency, a class II activity under jurisdiction of the Commanding General, U.S. Army Materiel Command, at Washington, D.C., is discontinued.
