I. U.S. ARMY COMBAT SURVEILLANCE AGENCY. *Effective 1 August 1962*, the U.S. Army Combat Surveillance Agency, a class II activity under the jurisdiction of the U.S. Army Materiel Command, at Arlington, Virginia, is discontinued.

II. U.S. ARMY TRANSPORTATION MATERIEL COMMAND. *Effective 1 November 1962*, the U.S. Army Transportation Materiel Command, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, at St. Louis, Missouri, is redesignated the U.S. Army Aviation and Surface Materiel Command.

III. OVERSEA SUPPLY AGENCIES. Section IV, General Orders No. 46, 1962, as reads "U.S. Army Oversea Supply Agency" at "New Orleans, La.," "U.S. Army Oversea Supply Agency" at "New York, N.Y.," and "U.S. Army Oversea Supply Agency" at "San Francisco, Calif." is amended to read:
