I. DISTINGUISHED SERVICE MEDAL. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, the Distinguished Service Medal (First Oak Leaf Cluster) for exceptionally meritorious and distinguished service in a position of great responsibility is awarded to:

VI...SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

First Lieutenant *James M. Crowder*, O5307319, Infantry, United States Army, a member of the 24th Aviation Company, 24th Infantry Division, United States Army, distinguished himself by heroism at Augsburg Army Airfield, Augsburg, Germany on 21 May 1962. Lieutenant *Crowder* was on duty in the 24th Aviation Company hangar, when a helicopter flown by a pilot of the Company, crashed, capsized, and within seconds began to burn. He immediately rushed to the scene of the accident to aid the trapped aviator. With complete disregard for his own personal safety, he assisted in removing the trapped pilot from the burning cockpit and placing him a safe distance away from the hazardous wreckage just prior to the exploding of the aircraft gas tanks. Lieutenant *Crowder's* prompt and heroic action in this emergency is in the highest traditions of the United States Army and reflects great credit on himself and the military service.

Specialist Five *Porfirio Hernandez*, RA18393117, United States Army, a member of the 24th Aviation Company, 24th Infantry Division, distinguished himself by heroism at Augsburg Army Airfield, Augsburg, Germany on 21 May 1962. Specialist *Hernandez* was on duty in the 24th Aviation Company hangar, when a helicopter flown by a pilot of the Company, crashed, capsized, and within seconds began to burn. He immediately rushed to the scene of the accident to aid the trapped aviator. With complete disregard for his own personal safety, he assisted in removing the trapped pilot from the burning cockpit and placing him a safe distance away from the hazardous wreckage just prior to the exploding of the aircraft gas tanks. Specialist *Hernandez'* prompt and heroic action in this emergency is in the highest tradition of the United States Army and reflects great credit on himself and the military service.

Sergeant First Class *Robert W. Levitt*, , United States Army, a member of the 24th Aviation Company, 24th Infantry Division, United States Army, distinguished himself by heroism at Augsburg Army Airfield, Augsburg, Germany on 21 May 1962. Sergeant *Levitt* was on duty in the 24th Aviation Company hangar, when a helicopter flown by a pilot of the Company crashed, capsized, and within seconds began to burn. He quickly secured the nearest fire extinguisher and rushed to the scene of the accident. Upon reaching the aircraft, he realized the extinguisher would not subdue the flames surrounding the trapped aviator. With complete disregard for his own personal safety, Sergeant *Levitt* voluntarily proceeded to physically rupture the bubble of the helicopter by kicking and pulling it apart with his hands. He then entered the burning cockpit of the helicopter, freed the trapped pilot from his seat belt and shoulder harness, and with the assistance of other personnel on the scene, placed him a safe distance away from the hazardous wreckage just prior to the exploding of the gas tanks. Sergeant *Levitt's* prompt and heroic action in this emergency is in the highest traditions of the United States Army and reflects great credit on himself and the military service.

Specialist Four *Billy R. Lewis*, , Infantry, United States Army, a member of Company D, 1st Airborne Battle Group, 504th Infantry, 8th Infantry Division, distinguished himself by heroism on 24 August 1962, near Patersbach, Germany. When Specialist *Lewis* observed a soldier pinned under an overturned two and one-half ton truck which was engulfed in flames and loaded with ammunition, he unhesitatingly went to his aid. With complete disregard for his own personal safety, he attempted to extricate the trapped man from the blazing wreckage, characterized by dense smoke, choking fumes, and live ammunition exploding every few seconds, hurling fragments in all directions. Despite the inferno of flames, he remained with the hazardous wreckage, digging the soil with his bare hands to free the victim, until blinding smoke and suffocating fumes forced him to withdraw. Again he returned to the dangerous wreckage and continued digging until he was struck by flying shrapnel and suffered a severe injury. Specialist *Lewis'* prompt and heroic action in this emergency is in the highest tradition of the United States Army and reflects great credit on himself and the military service.

Captain *Michael A. Nolan*, , Ordnance Corps, United States Army, a member of State Headquarters and Headquarters Detachment, California Army National Guard, distinguished himself by heroism on 31 July 1962, near Vallejo, California. While traveling on the highway, Captain *Nolan* witnessed an accident in which a pickup truck pulling a trailer coach went out of control, collided head-on with a passenger vehicle, landed on top of the car, and burst into flames. With complete disregard for his own personal safety, Captain *Nolan* unhesitatingly attempted to rescue five imprisoned victims from the blazing wreckage. When he found the door of the passenger car jammed, he broke the window with his bare fist to open it. Despite the intense heat and danger of a gas tank explosion, he bravely carried all of the five injured occupants to safety. Although he sustained cuts and burns during his rescue efforts, he continued to render aid and comfort to the injured until an ambulance arrived. Captain *Nolan's* perseverance, initiative, and prompt and heroic actions in this emergency are in the highest traditions of the United States Army and reflect great credit on himself and the military service.

Sergeant First Class *John P. Pajot, Jr.*, , Transportation Corps, United States Army, a member of the 522d Transportation Platoon (Barge Amphibious Resupply, Cargo Operations and Maintenance), United States Forces, distinguished himself by heroism on 20 July 1962, at Boat Basin

Number 4, United States Army Sub-Installation, Rochefort, France. While traveling as a passenger in a car, Sergeant *Pajot* noticed an individual climb over the guard rail adjacent to Boat Basin Number 4 and leap into the deep muddy water. Calling attention to the driver, who immediately stopped the car, Sergeant *Pajot* dashed to the basin, and in the darkness of the night, caught a glimpse of a figure floundering in the water and making no apparent effort to swim. With complete disregard for his own personal safety, he unhesitatingly dove, fully clothed, into the murky water and quickly arrived alongside the man, who was attempting to take his own life. When he tried to grasp him and bring him to the seawall, the man vigorously resisted efforts to save him. Realizing that the man was distraught and irresponsible, Sergeant *Pajot* subdued him, and with the assistance of another soldier, succeeded in moving him to the edge of the seawall, where he was removed from the water by other persons who were standing by. Sergeant *Pajot's* prompt and heroic action in this emergency is in the highest traditions of the United States Army and reflect great credit upon himself and the military service. (This award supersedes award of the Army Commendation Medal to Sergeant *Pajot* for heroism on 20 July 1962, as announced in General Orders Number 163, Headquarters, U.S. Army Communications Zone, Europe, dated 19 November 1962, amended by General Orders Number 1, Headquarters, U.S. Army Communications Zone, Europe, dated 2 January 1963.)

First Lieutenant *Paul N. Sper*, O87388, Infantry, United States Army, a member of Company D, 1st Airborne Battle Group, 504th Infantry, 8th Infantry Division, distinguished himself by heroism on 24 August 1962, near Patersbach, Germany. When Lieutenant *Sper* observed a soldier pinned under an overturned two and one-half ton truck which was engulfed in flames and loaded with ammunition, he unhesitatingly went to his aid. With complete disregard for his own personal safety, he attempted to extricate the trapped man from the blazing wreckage, characterized by dense smoke, choking fumes, and live ammunition exploding every few seconds, hurling fragments in all directions. Despite the inferno of flames, he remained with the hazardous wreckage, digging the soil with his bare hands to free the victim. He continued his efforts until he was struck by flying shrapnel and suffered a severe injury. Lieutenant *Sper's* prompt and heroic action in this emergency is in the highest tradition of the United States Army and reflects great credit on himself and the military service.
