**I..GENERAL COURTS-MARTIAL.** The Commanding Officer, III Corps and Fort Hood, Fort Hood, Texas, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial, *effective 8 April 1963.*

**II..U.S. ARMY MATERIEL COMMAND AVIATION FIELD OFFICE.** *Effective 1 April 1963,* the U.S. Army Materiel Command Aviation Field Office, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, at Washington, D.C. is discontinued.

**III..PLUM BROOK ORDNANCE WORKS, OHIO.** *Effective 15 March 1963,* the Plum Brook Ordnance Works, Ohio, was discontinued as an Army installation.

**IV..PLUM BROOK DEPOT ACTIVITY, OHIO.** *Effective 15 March 1963,* the Plum Brook Depot Activity, Ohio, was discontinued as an Army activity.

**V..UNITED STATES ARMY RESEARCH AND DEVELOPMENT OFFICE, PANAMA.** So much of section I, DA General Orders 13, 1962, as reads "Fort Sherman, Canal Zone" is amended to read "Fort Clayton, Canal Zone."

**VI..UNITED STATES ARMY CHEMICAL CORPS TROPIC TEST ACTIVITY.** *Effective 1 April 1963,* the United States Army Chemical Corps Tropic Test Activity, a class II activity under the jurisdiction of the Commanding General, Army Materiel Command, with station at Fort Clayton, Canal Zone, is discontinued and its functions, personnel, records and equipment are assigned to the United States Army Research and Development Office, Panama.
