I. U.S. ARMY MATERIEL COMMAND FIELD OFFICE. *Effective 15 April 1963*, the U.S. Army Materiel Command Field Office, is established at Albuquerque, New Mexico as a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command.

II. U.S. ARMY SIGNAL AVIATION TEST AND SUPPORT AGENCY. *Effective 1 April 1963*, the U.S. Army Signal Aviation Test and Support Agency, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is discontinued, and its functions, personnel, records, and equipment are transferred to the U.S. Army Aviation Test Board, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command.

III. TRANSFER OF COMMAND OF U.S. ARMY STANDARDIZATION GROUPS. 1. *Effective 17 May 1963*, the following class II research and development activities under the command of the Commanding General, U.S. Army Materiel Command are placed under the Command of the Chief of Research and Development, Department of the Army:

U.S. Army Standardization Group, Canada
Ottawa, Ontario, Canada.

U.S. Army Standardization Group, United Kingdom,
London, England.

2. Concurrent with the transfer of command, tables of distribution numbers are changed as indicated:
