I. GENERAL COURTS-MARTIAL. The Commanding Officer, United States Army Forces Southern Command, is designated by the Secretary of the Army pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial, *effective 25 June 1963*.

II. LOUISVILLE ARMY DEPOT, KENTUCKY. *Effective 1 July 1963*, the Louisville Army Depot, Kentucky, a class II installation under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is inactivated.

III. MT. RAINIER ARMY DEPOT, WASHINGTON. *Effective 1 July 1963*, the Mt. Rainier Army Depot, Washington, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is discontinued and its facilities made an integral part of Fort Lewis, Washington.

IV. ROSSFORD ARMY DEPOT, OHIO. *Effective 1 July 1963*, the Rossford Army Depot, Ohio, a class II installation under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is inactivated.

V. ENGINEER PROVING GROUND. Section X, General Orders No. 46, 1962, is amended to delete the "Engineer Proving Ground, Fort Belvoir, Virginia," under the column headings "From The Chief of Engineers" and "Proving Ground Activity." Functions, personnel, and equipment are a part of the U.S. Army Engineer Research and Development Laboratories, a class II activity at Fort Belvoir, Virginia, under the jurisdiction of Commanding General, U.S. Army Materiel Command.

VI. U.S. ARMY MATERIEL COMMAND ACTIVITIES. *Effective 1 August 1962*, the following class II activities, under the jurisdiction of the Commanding General, U.S. Army Materiel Command, are redesignated as follows:

VII. UNITS ENTITLED TO USAR AWARD. General Orders 14, 1963, is amended to include the 1st Judge Advocate General Detachment as a unit of the Fourth United States Army entitled to receive the Secretary of the Army Superior Unit Certificate.
