I--GENERAL COURTS-MARTIAL. The Commanding Officer, U.S. Army Terminal Command, Atlantic, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial, *effective 5 July 1963*.

II--GENERAL COURTS-MARTIAL. The Commanding Officer, U.S. Army Terminal Command, Gulf, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial, *effective 5 July 1963*.

III--GENERAL COURTS-MARTIAL. The Commanding Officer, Army Terminal Command, Pacific, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial, *effective 5 July 1963*.

IV--FORT NIAGARA, N.Y. *Effective 30 June 1963*, Fort Niagara, N.Y., a class I installation under the jurisdiction of the Commanding General, 1st U.S. Army, is placed in an inactive status.

V--U.S. ARMY CHEMICAL PROCUREMENT DISTRICT, NEW YORK. *Effective 15 July 1963*, the U.S. Army Chemical Procurement District, New York, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is discontinued. Functions and personnel will be reassigned to the AMC New York Procurement District, New York, N.Y., and Edgewood Arsenal, Md., both elements under the jurisdiction of the Commanding General, U.S. Army Materiel Command.
