**I. DISTINGUISHED SERVICE MEDAL.** By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, the Distinguished Service Medal for exceptionally meritorious and distinguished service in a position of great responsibility is awarded posthumously to:

**II. DISTINGUISHED SERVICE MEDAL.** By direction of the President, under the provisions of the Act of Congress, approved 9 July 1918, the Distinguished Service Medal for exceptionally meritorious and distinguished service in a position of great responsibility is awarded to:

**III. SILVER STAR.** By direction of the President, under the Act of Congress, approved 25 July 1963, the Silver Star for gallantry in action on the date indicated is awarded posthumously to:

Captain *Kenneth N. Good*, , Infantry, United States Army, distinguished himself by gallantry in action while engaged in military operations at Ap Tan Tho, Republic of Vietnam, on 2 January 1963. Captain *Good* was assigned as the Advisor to a Vietnamese infantry battalion which had the mission of securing a series of objectives, including the hamlet of Ap Tan Tho. While approaching the final objective, the battalion received intense small arms and automatic weapons fire from a determined and entrenched hostile force. At the risk of his life, Captain *Good* unhesitatingly moved

from the Battalion Command Post to the forward elements to apprise himself of the situation and to assist the Vietnamese commanders. Although the unit was receiving casualties and he was exposed to constant gunfire, he completely ignored the danger to assist in the selection of a route into the hostile lines. His heroic and brave action stabilized the Vietnamese units and served as an example to those around him. Shortly after, while occupying a vantage point with the forward unit, he was struck by a sniper's bullet. Although seriously wounded, he directed the aidmen to administer to the Vietnamese casualties and continued to encourage the friendly forces to pursue their defense efforts. Captain *Good's* conspicuous gallantry and unselfish actions are in the highest traditions of the United States Army, and reflect great credit on himself and the military service. (This award supersedes the award of the Bronze Star Medal with letter "V" device to Captain *Good* awarded for heroic achievement on the same date as announced in General Orders Number 18, Headquarters, United States Army, Pacific, dated 15 January 1963.)

**VI. SOLDIER'S MEDAL.** By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Private First Class *Frank P. Comito, Jr.*, , Armor, United  
States Army, a member of Headquarters and Headquarters Troop, 3d Squadron, 3d Armored Cavalry Regiment, United States Forces, Europe, distinguished himself by heroism on 24 August 1962, near Patersbach, Germany. When Private *Comito* observed a soldier pinned under an overturned two and one-half ton truck which was engulfed in flames and loaded with ammunition, he unhesitatingly went to his aid. With complete disregard for his own personal safety, he attempted to extricate the trapped man from the blazing wreckage, characterized by dense smoke, choking fumes, and live ammunition exploding every few seconds, hurling fragments in all directions. Despite the inferno of flames and the severe injury suffered by another volunteer rescue worker, he continued his diligent efforts until the trapped soldier was pulled to safety. Private *Comito's* prompt and heroic action in this

emergency is in the highest tradition of the United States Army and reflects great credit on himself and the military service.

Specialist Five *Garland R. Crawford*, , United States Army, while a member of Company A, 8th Engineer Battalion (Construction), 1st Cavalry Division, Eighth United States Army, distinguished himself by heroism on 6 March 1963, in Korea. Specialist *Crawford* unhesitatingly volunteered to traverse a mine field to rescue a soldier who was seriously wounded by a mine explosion. During more than one hour of extremely hazardous efforts in clearing a lane to the injured soldier, Specialist *Crawford* and his comrades located and disarmed numerous mines. When he and the other members of the rescue party had advanced to within approximately twenty meters of the injured soldier, a helicopter lowered a sling in an attempt to airlift him from the dangerous area. Observing that the soldier was too weak to tie himself securely to the sling and was in danger of falling or rolling onto other mines, Specialist *Crawford*, with complete disregard for his own personal safety, rushed through the remaining distance of the uncleared mine field, and assisted him into the sling. Specialist *Crawford's* heroic action, devotion to duty, and deep concern for a fellow soldier are in the highest traditions of the military service and reflect great credit on himself and the United States Army. (This award supersedes the award of the Army Commendation Medal to Specialist *Crawford* for heroism on 6 March 1963, in Korea, as announced in General Orders Number 84, Headquarters, Eighth United States Army, dated 15 May 1963.)

Private First Class *Oda O. Inglis, Jr.*, , United States Army, a member of Headquarters and Headquarters Company, 538th Engineer Battalion (Construction) distinguished himself by heroism on 17 December 1962, at Fort Knox, Kentucky. Private *Inglis* was on a surveying project with members of the Battalion in the vicinity of a kindergarten playground when he heard the screams of the children after a little girl had fallen through the ice of a nearby pond and submerged into the deep freezing water. He swiftly ran to the pond, crossed the ice of varying thickness, and with complete disregard for his own personal safety, bravely entered the water through the existing hole in the ice in an effort to rescue the child. When he failed to locate her, he came out of the water, quickly organized the other soldiers who were in the area, and with their assistance the child was found and removed from the icy water. Private *Inglis'* heroic action is in the highest traditions of the United States Army and reflects great credit on himself and the military service.

Platoon Sergeant *William H. Kelly*, , Infantry, United States Army, distinguished himself by heroism on 24 February 1963, at Moss Landing, California. While on the picnic grounds of Moss Landing, Sergeant *Kelly* heard shouts for help coming from three adults who were prevented by the undertow from rescuing a drowning boy who was drifting rapidly farther out into the ocean. With complete disregard for his own personal safety, he unhesitatingly entered the treacherous waters and swam to the child. Upon reaching the boy, he instructed him to take a firm grip on his shirt to enable towing. The boy became panic-stricken and grabbed Sergeant *Kelly* around the neck. With calmness and determination, he quickly submerged, broke the boy's hold, grabbed him firmly and, upon surfacing, treaded water until approached by a large cabin cruiser. When the cabin cruiser could not effect

the rescue, a small outboard skiff maneuvered close enough for him to safely assist the boy into it. Sergeant *Kelly's* sound judgment, perseverance, and heroic action are in the highest traditions of the United States Army and reflect distinct credit on himself and the military service. (This award supersedes the award of the Army Commendation Medal to Sergeant *Kelly* for heroism at Moss Landing, California, on 24 February 1963 as announced in General Orders Number 16, Headquarters, United States Army Training Center, Infantry and Fort Ord, California, dated 28 March 1963.)

Lieutenant Colonel *Benjamin L. Landis, Jr.*, , Army Intelligence and Security (then Major, Armor), United States Army, a member of Headquarters, 3d Reconnaissance Squadron, 3d Armored Cavalry Regiment, United States Forces, Europe, distinguished himself by heroism on 24 August 1962, near Patersbach, Germany. When Colonel *Landis* observed a soldier pinned under an overturned two and one-half ton truck which was engulfed in flames and loaded with ammunition, he unhesitatingly went to his aid. With complete disregard for his own personal safety, he attempted to extricate the trapped man from the blazing wreckage, characterized by dense smoke, choking fumes, and live ammunition exploding every few seconds, hurling fragments in all directions. Despite the inferno of flames and the severe injury suffered by another volunteer rescue worker, he continued his diligent efforts until the trapped soldier was pulled to safety. Colonel *Landis's* prompt and heroic action in this emergency is in the highest tradition of the United States Army and reflects great credit on himself and the military service.

Staff Sergeant *Salvatore A. Scanella*, , United States Army, while a member of Company A, 8th Engineer Battalion (Construction), 1st Cavalry Division, Eighth United States Army, distinguished himself by heroism on 6 March 1963, in Korea. Sergeant *Scanella* unhesitatingly volunteered to traverse a mine field to rescue a soldier who was seriously wounded by a mine explosion. During more than one hour of extremely hazardous efforts in clearing a lane to the injured soldier, Sergeant *Scanella* and his comrades located and disarmed numerous mines. When he and the other members of the rescue party had advanced to within approximately twenty meters of the injured soldier, a helicopter lowered a sling in an attempt to airlift him from the dangerous area. Observing that the soldier was too weak to tie himself securely to the sling and was in danger of falling or rolling onto other mines, Sergeant *Scanella*, with complete disregard for his own personal safety, rushed through the remaining distance of the uncleared mine field, and assisted him into the sling. Sergeant *Scanella's* heroic action, devotion to duty, and deep concern for a fellow soldier are in the highest traditions of the military service and reflect great credit on himself and the United States Army. (This award supersedes the award of the Army Commendation Medal to Sergeant *Scanella* for heroism on 6 March 1963, in Korea, as announced in General Orders Number 84, Headquarters, Eighth United States Army, dated 15 May 1963.)

First Lieutenant *John L. Shen*, , Armor, United States Army, distinguished himself by heroism on 8 May 1962, at Fort Polk, Louisiana. When an L-19 military aircraft crashed, and within seconds began to burn, Lieutenant *Shen* rushed to the area to assist the occupants. He succeeded in removing one of the individuals from the burning aircraft and placed him a safe distance away. With complete disregard for his own personal safety, and the danger of a gasoline explosion, he returned to the aircraft and made

a valiant attempt but was unable to evacuate the trapped pilot from the flaming wreckage. Lieutenant *Shen's* heroic action is in keeping with the finest traditions of the military service and reflects distinct credit on himself, the United States Army, and the military establishment. (This award supersedes the award of the Army Commendation Medal to Lieutenant *Shen* for heroism on 8 May 1962 at Fort Polk, Louisiana, as announced in General Orders Number 65, Headquarters Fourth United States Army, dated 19 June 1963.)

Specialist Five *Albert L. Shepard*, Armor, United States Army, while serving as a member of Company D, 2d Medium Tank Battalion, 69th Armor, Fort Benning, Georgia, distinguished himself by heroism on 13 December 1962, at Columbus, Georgia. Specialist *Shepard* was awakened by screams outside his quarters and discovered that his neighbor's mobile home was on fire with a small boy and girl trapped inside. The little girl was lying unconscious near the doorway of the trailer and was easily rescued by the other neighbors who had arrived on the scene, but the dense smoke within the trailer prevented the rescue of the little boy. Without regard for his own personal safety and the imminent danger of a gasoline explosion, Specialist *Shepard* unhesitatingly and courageously entered the trailer to search for the boy. Despite the choking fumes and blinding smoke, he succeeded in locating him and carried him out of the burning trailer within moments before it exploded. Specialist *Shepard's* heroic action is in the finest traditions of the military service and reflects distinct credit on himself and the United States Army.

Sergeant *Dustin C. Silver*, United States Army, while serving as a member of the United States Army Instructor Group (Junior Reserve Officers Training Corps), Fulton County High Schools, distinguished himself by heroism on 10 August 1962, at East Point, Georgia. When, during the middle of the night, Sergeant *Silver* noticed that a neighbor's home was on fire, he immediately rushed to their assistance. He succeeded in gaining entry into the burning dwelling, and found three of their small children huddled in the living room, near the door. After escorting the children to a place of safety, he discovered that their father was still inside. With complete disregard for his own personal safety, Sergeant *Silver* re-entered the blazing dwelling, and located the badly burned man lying on the floor in a state of shock. The dazed and injured man was reluctant to leave the premises, believing his children were still trapped inside, thus requiring Sergeant *Silver* to exert every effort in order to evacuate him from the blazing structure. Sergeant *Silver's* heroic action is in the highest tradition of the military service and reflects the utmost credit on himself and the United States Army.

Staff Sergeant *Forrest E. Todd*, United States Army, while a member of Company D, 1st Battle Group, 7th Cavalry, 1st Cavalry Division, Eighth United States Army, distinguished himself by heroism on 6 March 1963, in Korea. Sergeant *Todd* unhesitatingly volunteered to traverse a mine field to rescue a soldier who was seriously wounded by a mine explosion. During more than one hour of extremely hazardous efforts in clearing a lane to the injured soldier, Sergeant *Todd* and his comrades located and disarmed numerous mines. When he and the other members of the rescue party had advanced to within approximately twenty meters of the injured soldier, a helicopter lowered a sling in an attempt to airlift him from the dangerous area. Observing that the soldier was too weak to tie himself securely to the sling and was in danger of falling or rolling onto other mines, Sergeant *Todd*,

with complete disregard for his own personal safety, rushed through the remaining distance of the uncleared mine field, and assisted him into the sling. Sergeant *Todd's* heroic action, devotion to duty, and deep concern for a fellow soldier are in the highest traditions of the military service and reflect great credit on himself and the United States Army. (This award supersedes the award of the Army Commendation Medal to Sergeant *Todd* for heroism on 6 March 1963, in Korea, as announced in General Orders Number 84, Headquarters, Eighth United States Army, dated 15 May 1963.)

Specialist Five *Jesse E. Williamson*, , Artillery, United States Army, distinguished himself by heroism on 27 February 1963, while assigned to the United States Army Air Defense Board, Fort Bliss, Texas. Specialist *Williamson* observed a young boy and girl playing aboard a small homemade raft on a lake near El Paso, Texas, and moments later, saw the children slip from the overturned raft and fall into the twelve-foot deep water. He unhesitatingly ran from his home nearby, plunged into the lake, and swam sixty feet to where the children were struggling in the water. Although not an expert swimmer, Specialist *Williamson* displayed complete disregard for his own personal safety, and succeeded in moving both children toward the shore where he received some assistance with the little girl, and personally carried the boy out of the water. Specialist *Williamson's* unselfish conduct and heroic action in this emergency are in the highest traditions of the United States Army, and reflect distinct credit on himself and the military service.

**VII--BRONZE STAR MEDAL.** By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal for meritorious service in connection with military operations against hostile forces is awarded to:
