I. DISTINGUISHED SERVICE MEDAL. By direction of the President, under the provisions of the Act of Congress, approved 9 July 1918, the Distinguished Service Medal for exceptionally meritorious and distinguished service in a position of great responsibility is awarded to:

Colonel *Vincent J. Esposito*, , United States Army. June 1947 to October 1963.

II. SILVER STAR. By direction of the President, under the provisions of the Act of Congress, approved 25 July 1963, the Silver Star for gallantry in action is awarded to:

Captain *John W. Ault, Jr.*, , Infantry, United States Army, distinguished himself by gallantry in action while engaged in military operations on 13 April 1963. Captain *Ault* was serving as an Advisor to a Vietnamese Airborne Battalion when a helicopter landed in an opening in a dense jungle to evacuate two soldiers who had been wounded by hostile forces. As the helicopter landed, the northernmost company of the Battalion came under a fierce attack, characterized by intense small arms fire, and suffered heavy casualties. Captain *Ault* quickly waved the helicopter off the ground, and then, with complete disregard for his own personal safety, crossed an area swept by heavy small arms fire to reach a radio, communicated with the helicopter personnel, and requested additional support. Despite a wound from a hand grenade, he remained with the unit to advise and encourage them, and by his inspiring leadership and courageous actions, rallied the Vietnamese soldiers to hold their position and to pursue their defense efforts. Captain *Ault's* conspicuous gallantry and unselfish actions are in the highest traditions of the United States Army and reflect great credit upon himself and the military service. (This award supersedes the award of the Bronze Star Medal with "V" device to Captain *Ault* for heroism on 13 April 1963 as announced in General Orders Number 251, Headquarters, United States Army, Pacific, dated 26 June 1963.)

IV. SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Sergeant First Class *Roy P. Barefoot*, , Infantry, United States Army, a member of Company E, Infantry School Battalion, distinguished himself by heroism on 7 May 1963, at Fort Benning, Georgia. Sergeant *Barefoot* was serving as Safety Noncommissioned Officer for a hand grenade class when a student, who was preparing to throw a live grenade, accidentally dropped the armed grenade, which rolled several feet to the rear of the throwing bay. With complete disregard for his own personal safety, Sergeant *Barefoot* dove toward the grenade, snatched it from the ground and while lying on his side, threw it over a concrete wall into the impact area. The grenade had barely cleared the wall when it detonated. Through his courage and spontaneous reaction to a dangerous situation, he averted injury and possible loss of life to the personnel in the area. Sergeant *Barefoot's* prompt and heroic action in this emergency is in the highest traditions of the military service and reflects great credit upon himself and the United States Army.

Captain *Richard D. Haskell*, (then First Lieutenant, Medical Corps, United States Army, distinguished himself by heroism at the United States Army Tripler General Hospital, in Hawaii, on 6 May 1963. When Captain *Haskell* learned that a female patient was observed sitting on the edge of a narrow ledge abutting a patio on the ninth floor of the hospital, he rushed to the scene to render assistance. He quickly assessed the hazardous situation and determined that the depressed, hysterical patient intended to leap to the ground, over one hundred feet below. With ingenuity and speed, he requested the trouser belts of the men in the vicinity, assembled them into a safety belt, and attached it to the rear of his own belt. Then, with complete disregard for his own personal safety, and only the protection of the makeshift safety belt, he unhesitatingly jumped onto the ledge and returned the despondent patient to safety. Captain *Haskell's* heroic action in this emergency is in the highest traditions of the United States Army and reflects great credit upon himself and the military service.
