I..DISTINGUISHED SERVICE MEDAL. 1. By direction of the President, under the provisions of the Act of Congress, approved 9 July 1918, the Distinguished Service Medal for exceptionally meritorious and distinguished service in a position of great responsibility is awarded to:

Major General *Charles L. Decker*, United States Army. April 1957 to December 1963.

Major General *Jean E. Engler*, United States Army. May 1961 to September 1963.

2. By direction of the President, under the provisions of the Act of Congress, approved 9 July 1918, the Distinguished Service Medal (First Oak Leaf Cluster) for exceptionally meritorious and distinguished service in a position of great responsibility is awarded to:

Lieutenant General *Alfred D. Starbird*, (then Major General), United States Army. November 1961 to October 1962.

Major General *Robert H. Wienecke*, United States Army. October 1954 to December 1963.

II..SILVER STAR. By direction of the President, under the provisions of the Act of Congress, approved 25 July 1963, a Silver Star for gallantry in action is awarded posthumously to:

Captain *Donald V. McGregor*, Infantry, United States Army, distinguished himself by gallantry in action while engaged in military operations on 13 August 1963. Captain *McGregor* demonstrated sound judgment, fortitude, and professional competence as an Infantry Unit Advisor to the 51st Infantry Regiment, 25th Infantry Division, Army of the Republic of Vietnam. When a lead company of Vietnamese forces received hostile gun fire from ambush during a routine battalion operation, Captain *McGregor* disregarded his own personal safety, proceeded to the forward area, and advised the leading company commander in the most effective tactics and maneuvers to achieve military objectives. His courageous action, personal example, and dedicated devotion to duty inspired the Vietnamese officers and men to greater efforts and assured the success of the mission. Throughout this entire day of combat operations, he rendered invaluable assistance, advice, and encouragement to his Vietnamese comrades until he was mortally wounded. Captain *McGregor's*

conspicuous gallantry is in the highest traditions of the United States Army and reflects great credit upon himself and the military service.

III--SILVER STAR. By direction of the President, under the provisions of the Act of Congress, approved 25 July 1963, the Silver Star for gallantry in action is awarded to:

Captain *Gordon B. Frank*, Infantry, United States Army distinguished himself by gallantry in action while engaged in military operations on 29 June 1963. As an Advisor to a Vietnamese Battalion (Civil Guard), Captain *Frank* displayed a rare combination of professional knowledge, sound judgment, and devotion to duty, and rendered invaluable assistance, advice, and encouragement to the Battalion in accomplishing its military objectives. When the operations of the Battalion were deterred by hostile small arms and automatic weapons fire, he disregarded his own personal safety and remained with the forward troops in an effort to rally them. Forced to defend himself against point blank range hostile fire, and armed only with a pistol and hand grenades, he single-handedly annihilated three hostile positions. His courageous action, personal example, and dedication to duty served as an inspiration to his Vietnamese comrades and assured the success of the operations. Captain *Frank's* conspicuous gallantry is in the highest traditions of the United States Army and reflects great credit upon himself and the military service.

IV--LEGION OF MERIT. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit for exceptionally meritorious conduct in the performance of outstanding service is awarded posthumously to:

Colonel *Joseph E. Murray*, Quartermaster Corps, United States Army. August 1962 to June 1963.

Colonel *Thomas E. Patton, Jr.*, Medical Corps, United States Army. August 1954 to May 1963. 2. By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Officer) for exceptionally meritorious conduct in the performance of outstanding service is awarded to:

VII. SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded posthumously to:

Sergeant *Robert E. O'Rear*, United States Army, distinguished himself by heroism on 25 July 1963, near Elizabeth, North Carolina, while serving as a member of Headquarters Company, United States Army Airborne, Electronics and Special Welfare Board, Fort Bragg, North Carolina. As Noncommissioned Officer in Charge of a Team testing antennas, Sergeant *O'Rear* was directing the lowering of a test antenna from a position between the antenna and a 7200 volt power line when the lowering line snagged on the vehicle to which the antenna was attached. The antenna stopped its descent and leaned toward the power line. While one of the soldiers found and released the snagged line, another was balancing the antenna when it started to fall toward the power line. Upon observing the falling antenna and realizing the great danger to the man balancing it, Sergeant *O'Rear* completely disregarded his personal safety, leaped toward the mast, knocking it out of the soldier's hand as it made contact with the power line, and saving the life of a fellow soldier at the sacrifice of his own. Sergeant *O'Rear's* heroic action is in the highest traditions of the United States Army and reflects great credit upon himself and the military service.

VIII. SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Specialist Five *John C. Brewer*, United States Army, a member of Company A, 3d Aviation Battalion, distinguished himself by heroism on 6 June 1963, near Nassig, Germany. Specialist *Brewer* was serving as Crew Chief on a CH-34 helicopter transporting six passengers and cargo when an electrical malfunction exploded the battery and set the aircraft on fire. With complete disregard for his own personal safety, he fought the fire with a hand fire extinguisher while the aircraft was airborne. Upon landing, he quickly directed the evacuation of the passengers and, despite an impending gasoline explosion, sickening fumes, and dense smoke, he continued to fight the fire. His perseverance, courage, and diligent efforts averted the possible loss of life and valuable government property. Specialist *Brewer's* prompt and heroic action in this emergency is in the highest traditions of the military service and reflects great credit upon himself and the United States Army.

Specialist Five *Russell A. Curtis*, United States Army, a member of Headquarters and Headquarters Company, 1st Battalion (Medium), 117th Infantry, distinguished himself by heroism at Fort Stewart, Georgia, on 19 July 1963. During the refueling portion of a training exercise, Specialist *Curtis* observed an accident involving an armored personnel carrier. As the carrier was crossing an open ditch, the mounted .50 caliber machine gun swung loose and struck the driver in the head, rendering him unconscious, and sending the vehicle moving toward a group of soldiers. With complete disregard for his own personal safety, Specialist *Curtis* dashed forward, mounted the moving armored personnel carrier, and by swiftly lowering himself into it through the commander's hatch, succeeded in bringing the vehicle to a rapid halt. He then rendered first aid to the unconscious driver and assisted in removing him to the Battalion aid station. Specialist *Curtis's* prompt and heroic action in this emergency averted the possible loss of life and government property, and reflects great credit upon himself and the military service.

Second Lieutenant *Harley C. Davis*, Infantry, United States Army, a member of Company B, 1st Battalion, 50th Infantry, 2d Armored Division, distinguished himself by heroism at House Creek Range, Fort Hood, Texas, on 5 July 1963. As Officer-in-Charge, Lieutenant *Davis* was positioned on the firing line to direct the live-fire phase of a flame-thrower training exercise. Suddenly, a spot on the firing line near him became engulfed in a billowing cloud of flames as a firer panicked, stumbled, and turned the flame-thrower into the wind as he fell backwards onto the ground with the weapon still spewing its deadly fuel. With complete disregard for his own personal safety, Lieutenant *Davis* remained in the inferno of burning fuel to wrest the flamethrower from the helpless firer, subjecting himself to excruciating pain inflicted by the passage of the flame across his face. He then ignored his own serious injuries, rolled the blazing man out of the conflagration and, by using his own body, smothered the flames of the burning fuel on his fellow soldier. Lieutenant *Davis's* heroic action is in the highest traditions of the military service and reflects great credit upon himself and the military service. (This award supersedes award of the Army Commendation Medal for meritorious service from September 1961 to September 1963 as announced in General Orders Number 156, Headquarters, 2d Armored Division, Fort Hood, Texas, dated 24 September 1963.)

Captain *Freeman I. Howard*, (then First Lieutenant), Corps of Engineers, United States Army, distinguished himself by heroism as a member

of Company A, 82d Engineer Battalion, United States Forces, on 12 June 1963, near Darmstadt, Germany. While leading the Company in a convoy, Captain *Howard* witnessed an accident involving a five ton truck which had six men aboard and a trailer containing thousands of pounds of demolitions as it struck a bridge abutment and burst into flames. With complete disregard for his own personal safety, he rushed to the burning truck, swiftly extinguished the fire in one man's hair, pulled a second soldier away from the vehicle, and then put out the flames on a third man fleeing from the scene of the fire. Captain *Howard* then bravely returned to the flaming wreckage and evacuated a soldier who was trapped in the equipment of the truck. Through his courage and perseverance, he succeeded in extricating the man, and pulling him to a safe area. Captain *Howard's* heroic action in this emergency is in the highest traditions of the United States Army and reflects great credit upon himself and the military service. (This award supersedes award of the Army Commendation Medal for heroism on 12 June 1963, as announced in General Orders Number 35, Headquarters, VII Corps, APO 107, dated 21 August 1963.)

Sergeant First Class *Conrado Martinez*, United States Army, a member of Service Battery, McGregor Guided Missile Range Battalion, 1st Guided Missile Group, 1st Guided Missile Brigade, United States Army Air Defense Center, distinguished himself by heroism at Fort Bliss, Texas, on 8 February 1963. Sergeant *Martinez* was in his quarters when he heard calls for help to rescue a small boy trapped in a burning dwelling across the street. He rushed to the fire and, with complete disregard for his own personal safety, unhesitatingly entered the burning home to evacuate the boy. Although he was repelled by the intense flames and dense smoke three times, he succeeded in catching the frightened, fleeing boy and removing him from the blazing building. He then re-entered the burning structure and diligently fought the blaze until the heat and smoke forced his retreat. Sergeant *Martinez's* prompt and heroic actions are in the highest traditions of the military service and reflect great credit upon himself and the United States Army. (This award supersedes award of the Army Commendation Medal (1st OLC) for heroism on 8 February 1963, as announced in General Orders Number 104, Headquarters, United States Army Air Defense Center, dated 23 July 1963.)

IX--BRONZE STAR MEDAL. By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal for meritorious service in connection with military operations against hostile forces is awarded to:

Lieutenant Colonel *Stanley D. Fair*, Chemical Corps, United States Army. November 1962 to October 1963.

X--AIR MEDAL. By direction of the President, under the provisions of Executive Order 9158, 11 May 1942, as amended by Executive Order 9242-A, 11 September 1942, an Air Medal for heroism while participating in aerial flight is awarded by the Department of the Army, posthumously, to:

Captain *Kenneth J. Alves*, Armor, United States Army, a member of the Aviation Section, Detachment L (Provisional), United States Army Advisory Group to Korea, distinguished himself by heroism while participating in aerial flight near Wonju, Korea, on 17 July 1963. As Pilot of an OH-23D helicopter, Captain *Alves* demonstrated outstanding flying ability, perseverance, and sound judgment in his voluntary efforts to rescue thirty Korean women and children from a small island in the Somgang River which was

swollen by the torrential rains of Typhoon Wendy. With complete disregard for his own personal safety, and despite the darkness, heavy rainfall, and hazardous flying conditions, he quickly located the stranded people and effectively completed seven lifts from the island threatened by inundation. Captain *Alves'* exceptional flying skill and heroic action during this mercy mission reflect distinct credit upon himself and the military service. (This award supersedes award of the Army Commendation Medal for outstanding courage on 17 July 1963 as announced in General Orders Number 81, Headquarters, U.S. Army Advisory Group, Korea, dated 14 August 1963.)

XI--AIR MEDAL. By direction of the President, under the provisions of Executive Order 9158, 11 May 1942, as amended by Executive Order 9242-A, 11 September 1942, an Air Medal (Fifth Oak Leaf Cluster) for heroism while participating in aerial flight is awarded by the Department of the Army to:

Chief Warrant Officer *Dennis L. Pullen*, Transportation Corps, United States Army, a member of the 25th Aviation Company, 25th Infantry Division, distinguished himself by heroism while participating in aerial flight on 18 July 1963. As Aircraft Commander of a CH-21C helicopter, Chief Warrant Officer *Pullen* demonstrated outstanding flying ability, courage, and sound judgment when confronted with an extreme emergency during a night parachute drop south of Wheeler Air Force Base, Hawaii. Upon investigating the sudden yaw and buffet of the aircraft after the exit of the last parachutist, he learned that the top of a jumper's parachute was caught on the right main landing gear of the helicopter. As the parachute became partially inflated, it came perilously close to the aft rotor blades and whipped the jumper about violently. Realizing the great danger to the parachutist and personnel aboard the helicopter, he slowed the aircraft as much as possible to protect the parachutist from entanglement in the aft rotor system, and to avert a crash of the helicopter. He then displayed unique flying techniques and, despite the absence of landing lights and ground assistance, succeeded in safely lowering the parachutist in a Drop Zone. Chief Warrant Officer *Pullen's* exceptional flying skill and heroic action in this emergency reflect distinct credit upon himself and the military service.
