I. DISTINGUISHED SERVICE CROSS. By direction of the President, under the provisions of the Act of Congress, approved 25 July 1963, the Distinguished Service Cross for extraordinary heroism in action is awarded to:

Chief Warrant Officer *Keith R. Borck*, Transportation Corps, United States Army, while a member of the 93d Transportation Company, distinguished himself by extraordinary heroism in connection with military operations involving an opposing force in the Republic of Vietnam, on 2 January 1963. As an Aircraft Commander, Chief Warrant Officer *Borck* demonstrated professional skill, decisive leadership, and fortitude on his fourth mission into an assault zone in support of a military operation conducted by the Armed Forces of the Republic of Vietnam in defense of their homeland. When his aircraft was struck by automatic weapons fire, inflicting major damage to the aircraft and wounding the co-pilot, he evacuated the crew to a rescue helicopter. As the helicopter attempted to take off, it too was damaged by intense automatic weapons fire which wounded all of the crew members. Chief Warrant Officer *Borck* voluntarily and bravely exposed himself to the automatic weapons fire while evacuating both crews, placing them in a defilade position, and administering first aid to his wounded comrades. Then, as a second rescue helicopter returned to effect the rescue, it was struck by recoilless rifle fire and crashed. With complete disregard for his own personal safety, Chief Warrant Officer *Borck* dashed through intense weapons fire, reached the downed aircraft and, while exposed to the onslaught, tore out plexiglass panels and extricated the crew. For 3 hours they lay in a wet, muddy rice paddy under constant sniper fire. When hostile strafing prevented a third aircraft from effecting the rescue, he led the men to a more protected area and organized a perimeter defense until an aircraft finally succeeded in effecting their evacuation. Chief Warrant Officer *Borck's* conspicuous gallantry and extraordinary heroic actions are in the highest traditions of the United States Army and reflect great credit upon himself and the military service. (This award supersedes the award of the Bronze Star Medal with "V" device to Chief Warrant Officer *Borck* for heroism on 2 January 1963 as announced in General Orders Number 278, Headquarters, United States Army, Pacific, dated 10 July 1963.)

V--DISTINGUISHED FLYING CROSS. By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Distinguished Flying Cross for heroism while participating in aerial flight is awarded by the Department of the Army to:

Major *Garland B. King, Jr.*, Signal Corps, United States Army, distinguished himself by heroism while participating in aerial flight as a Pilot of a UH-1B helicopter and member of the Army Concept Team in Vietnam, on 11 May 1963. Major *King* unhesitatingly volunteered to participate in a hazardous aerial mission to transport supplies to the 7th Infantry Regiment, 5th Division, Army of the Republic of Vietnam, while it was under heavy attack by hostile forces. Despite the dangerous tactical situation and perilous flying conditions, he performed this difficult task with fortitude, initiative, and unique flying skill. In the unarmed and unescorted helicopter, he delivered approximately three tons of supplies during five successive trips to the regimental area. Then, upon completion of the mission, he displayed courage, determination, and decisive leadership when the aircraft was subjected to intense gun fire, and despite a punctured fuel tank and a wounded crew chief, Major *King* succeeded in flying the aircraft back to the base. His heroic actions, flying ability, and devotion to duty are in the highest traditions of the military service and reflect great credit upon himself and the United States Army.

VI--BRONZE STAR MEDAL. By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal for meritorious service in connection with military operations against hostile forces is awarded to:

VII--AIR MEDAL. By direction of the President, under the provisions of Executive Order 9158, 11 May 1942, as amended by Executive Order 9242-A, 11 September 1942, an Air Medal for heroism while participating in aerial flight is awarded by the Department of the Army to:

Corps, United States Army, while serving as a member of the 36th Transportation Company (Light Helicopter), 54th Transportation Transport Aircraft Battalion, distinguished himself by heroism while participating in aerial flight on 5 November 1961, near Frankfurt, Germany. As a Helicopter Aviator, Chief Warrant Officer *Austin* demonstrated unique flying skill, perseverance, and sound judgment in the performance of a dangerous evacuation mission. When notified of the need of an aeromedical evacuation of two seriously injured soldiers from a confined and hazardous area near Aschaffenburg, Germany, to the 97th General Hospital at Frankfurt, he unhesitatingly volunteered for this night mission. By his skill in maneuvering the helicopter at low altitudes and with only the aid of truck headlights to mark the landing site, he succeeded in landing the aircraft on an athletic field enveloped in dense fog. Despite the absence of instrument approach facilities at both Aschaffenburg and the 97th General Hospital at Frankfurt, he efficiently evacuated the patients and successfully completed the perilous round-trip flight. Chief Warrant Officer *Austin's* courageous actions, outstanding flying ability, and dedicated devotion to duty in this emergency mission reflect great credit upon himself and the military service.

Specialist Five *Donald L. Hitchcock*, United States Army,
while serving as a member of the 36th Transportation Company (Light Helicopter), 54th Transportation Transport Aircraft Battalion, distinguished himself by heroism while participating in aerial flight on 5 November 1961, near Frankfurt, Germany. As a Helicopter Crew Chief, Specialist *Hitchcock* demonstrated professional competence, perseverance, and sound judgment in the performance of a dangerous evacuation mission. When notified of the need of an aeromedical evacuation of two seriously injured soldiers from a confined and hazardous area near Aschaffenburg, Germany, to the 97th General Hospital at Frankfurt, he unhesitatingly volunteered for the night mission. He rendered invaluable assistance to the pilots in their maneuvering of the helicopter at low altitudes with only the aid of truck headlights to mark the landing site, and was instrumental in the successful landing of the aircraft on an athletic field enveloped in dense fog. Despite the absence of instrument approach facilities at both Aschaffenburg and the 97th General Hospital at Frankfurt, he displayed determination and professional skill which contributed in great measure to the efficient evacuation of the patients and to the successfully completed perilous round-trip flight. Specialist *Hitchcock's* courageous actions and dedicated devotion to duty in this emergency mission reflect great credit upon himself and the military service.
