I. GENERAL COURTS-MARTIAL. The Commanding Officer, U.S. Army Area Command, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial, *effective 1 July 1964*.

II. FINANCE CORPS BOARD, U.S. ARMY, WASHINGTON, D.C. *Effective 30 June 1964*, the Finance Corps Board, U.S. Army, a Class II activity under the jurisdiction of the Chief of Finance, is discontinued.

III. U.S. ARMY COMBAT DEVELOPMENTS COMMAND FINANCE AGENCY. *Effective 1 July 1964*, the U.S. Army Combat Developments Command Finance Agency is established at Fort Benjamin Harrison, Ind., as a class II activity under the jurisdiction of the Commanding General, U.S. Army Combat Developments Command.

IV. LENAPE ORDNANCE MODIFICATION CENTER, DEL. *Effective 3 April 1964*, the Lenape Ordnance Modification Center, Del., was discontinued as a Department of the Army installation.

V. NATIONAL BOARD FOR THE PROMOTION OF RIFLE PRACTICE. 1. *Effective 15 May 1964*, Colonel Merle R. Preble, USA, is announced as a member of the National Board for the Promotion of Rifle Practice, as Executive Officer of the National Board for the Promotion of Rifle Practice, and as Director of Civilian Marksmanship, vice Colonel John K. Lee, Jr., USA, Retired.

2. Section I, GO 54, 1962, is amended in accordance with the above.

VI. FLORIDA MILITARY ACADEMY, PLANTATION, FLA. *Effective 7 April 1964*, the National Defense Cadet Corps Unit at Florida Military Academy, Plantation, Fla., was withdrawn.
