 I_{-} . MERITORIOUS UNIT COMMENDATION. By direction of the Secretary of the Army, under the provisions of paragraph 203, AR 672-5-1, the Meritorious Unit Commendation is awarded to the following units of the United States Army for exceptionally meritorious achievement in the performance of outstanding services during the period indicated. The citations read as follows:

THE 8TH FIELD HOSPITAL with attached units, the 20th Preventive Medical Unit, the 7th Medical Laboratory, and the 36th Dental Detachment, distinguished itself by exceptionally meritorious conduct in the performance of outstanding services in support of military operations in the Republic of Vietnam during the period February 1963 to September 1963. The members of these elements demonstrated dedicated devotion to duty, sound judgment, and professional competence by providing the highest standards of medical, dental, and preventive medicine support in a counterinsurgency environment. Through the untiring efforts of these units, significant improvements were attained in all aspects of a medical program designed to provide services to inpatients, outpatients, and combat troops. Their outstanding accomplishments included the addition of convalescent facilities which decreased evacuations out of Vietnam; the implementation of highly effective hygienic programs that insured a low incidence of tropical disease among United States military personnel; and provisions to furnish medical care, assistance, and instruction to Vietnamese nationals which materially enhanced relationships between both governments. The professional skill, diligence, and technical knowledge of the professional staff were reflected in the high recovery rate of the United States military patients at the 8th Field Hospital. The professional acumen and unselfish actions displayed by the members of the 8th Field Hospital and attached units during this critical period reflect distinct credit upon themselves and the military service of the United States.

THE 73D AVIATION COMPANY (AIRPLANE SURVEILLANCE) (LIGHT) distinguished itself by exceptionally meritorious conduct in the performance of outstanding services in support of military operations in the Republic of Vietnam during the period May 1963 to December 1963. The members of this Company demonstrated professional competence, perseverance, and fortitude by providing outstanding aerial reconnaissance, surveillance, target acquisition, and command control support for the United States Armed Forces and their allies during counterinsurgency operations in Vietnam. This effective support resulted from the concerted effort of the Company while participating in thousands of flying hours and missions, and maintaining a high aircraft availability rate despite a myriad of obstacles and hazards. Although the Company members were widely dispersed and operating from fifteen locations throughout Vietnam, and constantly subjected to aircraft maintenance complications resulting from hostile gun fire and inadequate landing

sites, they successfully performed the most difficult task which insured the success of the unit's mission. The determination, devotion to duty, and esprit de corps displayed by the members of the 73d Aviation Company during this critical period reflect great credit upon themselves and the military service of the United States.
