I. DISTINGUISHED SERVICE CROSS. By direction of the President, under the provisions of the Act of Congress, approved 25 July 1963, the Distinguished Service Cross for extraordinary heroism in action is awarded posthumously to:

Captain *Morris R. McBride*, , Infantry, United States Army, distinguished himself by extraordinary heroism in connection with military operations involving an opposing force in the Republic of Vietnam, on 3 March 1964. As an Advisor to a Company in the Army of the Republic of Vietnam, Captain *McBride* demonstrated fortitude, professional skill, and determination by rendering invaluable assistance to Vietnamese elements when they were suddenly subjected to heavy machine gun fire and mortars by hostile forces. When the initial attack wounded the company commander and several other soldiers, Captain *McBride* displayed complete disregard for his own personal safety and bravely exposed himself to the intense gun fire while rallying the members of two platoons which had become widely dispersed during the onslaught. Upon assuming command of the leaderless company, and while still under flanking fire, he moved among the members of the company giving them assistance, directions, and encouragement. Then, with sound judgment, professional competence, and steadfast courage, he directed the company's withdrawal through successive positions, remained with the covering force that was the last to withdraw, and continued his dauntless efforts until he was mortally wounded as he stopped to assist the wounded Vietnamese commander. His intrepid conduct, unselfish actions, and devotion to duty inspired his Vietnamese comrades to pursue their efforts in the defense of their homeland and curtailed the activities of the hostile forces. Captain *McBride's* conspicuous gallantry and extraordinary heroic actions are in the highest traditions of the United States Army and reflect great credit upon himself and the military service.

III--SILVER STAR. By direction of the President, under the provisions of the Act of Congress, approved 9 July 1918, a Silver Star for gallantry in action is awarded to:

Platoon Sergeant *Franklin D. Canterbury*, , United States Army, distinguished himself by gallantry in action while engaged in military operations in Vietnam on 3 March 1964. As an Advisor to a Company in the Army of the Republic of Vietnam, Sergeant *Canterbury* demonstrated fortitude, professional skill, and perseverance by rendering invaluable assistance to Vietnamese elements when they were suddenly subjected to heavy machine gun and mortars by hostile forces. When the initial attack wounded the Vietnamese company commander and several other soldiers, and placed the leaderless company under the direction of an American Captain, Sergeant *Canterbury* displayed complete disregard for his own personal safety and bravely exposed himself to an intense volume of gun fire as he accompanied the wounded to covered positions. While still under flanking fire, he demonstrated steadfast courage and professional competence which curtailed the hostile action, and then, with dauntless efforts, attempted to evacuate the American officer who had been mortally wounded. His determination, unselfish actions, and dedicated devotion to duty prevented further losses to the Vietnamese forces and led to the helicopter evacuation of his commanding officer. Sergeant *Canterbury's* conspicuous gallantry is in the highest traditions of the United States Army and reflects great credit upon himself and the military service.

VI. SOLDIER'S MEDAL. By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Specialist Four *Bernard J. Blazys, Jr.*, , United States Army, while serving as a member of Company A, 3d Battalion, 4th Brigade, Fort Ord, California, distinguished himself by heroism on 29 September 1963, at Marina Beach, California. When Specialist *Blazys* heard calls for help from two youths who had been riding an air mattress and were suddenly rendered helpless when caught in a treacherous rip tide fifty yards from the beach, he immediately went to their aid. With complete disregard for his own personal safety, he plunged into the surf and, despite the heavy seas, attempted to rescue the young men. After one of the youths succeeded in reaching the shore, Specialist *Blazys'* efforts to rescue the second young man were in vain as the youth disappeared in the ocean. Specialist *Blazys'* heroic actions are in the highest tradition of the military service and reflect distinct credit upon himself and the United States Army.

Staff Sergeant *Robert L. Dameron, Jr.*, (then Specialist Four), United States Army, distinguished himself by heroism on 16 August 1962 in Contrisson, France while performing duties as a driver and team chief of Company B, 69th Signal Battalion. As Sergeant *Dameron* was driving a truck through the center of Contrisson, the gasoline-loaded trailer of

the vehicle became engulfed in flames. To avert an imminent explosion in the village, he displayed complete disregard for his own personal safety and drove the burning vehicle to an open field in the outskirts of the town. As the gas cans in the trailer started to explode, he succeeded in detaching the enflamed one and one-half ton generator set from the truck while he was sprayed with a stream of water by French firemen who arrived on the scene. By his prompt actions and sound judgment, he managed to save costly government communications equipment and prevented possible injury and damage to the village and population of Contrisson, France. Sergeant *Dameron's* heroic conduct in this emergency is in the highest traditions of the United States Army and reflects great credit upon himself and the military service. (This award supersedes award of the Army Commendation Medal to Sergeant *Dameron* for heroism on 16 August 1962 in Contrisson, France as announced in General Orders Number 106, Headquarters, United States Army Transportation Center and Fort Eustis, dated 26 November 1963.)

Staff Sergeant *Franklin D. Hill*, , United States Army, a member of Company A, 144th Signal Battalion, distinguished himself by heroism near Goeppingen, Germany, on 27 May 1963. Sergeant *Hill* was on the scene when a UH-1B helicopter crashed while lowering an 880-pound object into position on a bell tower of a church. With complete disregard for his own personal safety and despite an impending fuel explosion, he unhesitatingly entered the wreckage and succeeded in stopping the engine which was still running. He then repeatedly displayed his courage and perseverance by re-entering the aircraft three times to evacuate the crew members. Sergeant *Hill's* prompt and heroic action in this emergency is in the highest traditions of the military service and reflects great credit upon himself and the United States Army. (This award supersedes award of the Army Commendation Medal for heroism near Goeppingen, Germany, on 27 May 1963, as announced in General Orders Number 103, Headquarters, 4th Armored Division, dated 18 July 1963.)

Captain *Paul R. Pickel*, , Quartermaster Corps, United States Army, distinguished himself by heroism on 14 January 1964, in the vicinity of Pershing Park Housing Area, Fort Hood, Texas. While Captain *Pickel* was driving to his home in Pershing Park, he observed a young boy floundering in the waters of an ice covered pond. He quickly stopped his car, rushed to the pond and, with complete disregard for his own personal safety, entered the freezing water in an effort to rescue the child. When difficulty in breaking the ice slowed down his progress, he returned to the shore and exposed his wet body to the freezing temperature as he dashed to the opposite side of the pond to get closer to the boy. He then courageously re-entered the pond and broke the ice with his hands in an attempt to reach the spot where the child had submerged. With perseverance and fortitude, he continued his search for the boy until he himself was physically exhausted and had to be pulled to safety by a bystander. Captain *Pickel's* unselfish and heroic actions in this emergency are in the highest traditions of the United States Army and reflect great credit upon himself and the military service. (This award supersedes award of the Army Commendation Medal to Captain *Pickel* for meritorious achievement on 14 January 1964 as announced in General Orders Number 18, Headquarters, III Corps and Fort Hood, dated 7 February 1964.)

Sergeant *Robert T. Robinson*, , United States Army, distinguished himself by heroism as a member of Headquarters and Headquarters

Company, 10th Special Forces Group (Airborne), 1st Special Forces, on 24 October 1963, near Stanville, France. While travelling in a military convoy, Sergeant *Robinson* observed that the truck preceding his vehicle had plunged down a steep embankment and was burning furiously. Sergeant *Robinson* ran down the embankment and, upon approaching the burning truck, stopped to render aid to a burned soldier fleeing from the scene. Then, with complete disregard for his own personal safety and despite the danger of an impending gasoline explosion, he attempted to evacuate a soldier who was trapped in the blazing vehicle. Although repelled twice by the dense smoke and heat, he succeeded in extricating the injured man and then administered first aid to him while waiting for medical assistance. Sergeant *Robinson's* heroic action in this emergency is in the highest traditions of the United States Army and reflects the utmost credit upon himself and the military service.

As Pilot of an Army U8D aircraft, Major *Asbury* demonstrated unique flying ability and fortitude in the performance of numerous and extremely hazardous evacuation missions in support of United Nations operations following an uprising in the Republic of the Congo. With full knowledge of several fatalities, he displayed complete disregard for his own personal safety and skillfully conducted surveillance flights into the interior to locate isolated religious missions and call for helicopter and small aircraft to the danger sites for the evacuation of people whose lives were in jeopardy. Through his wholehearted efforts, courage, and skill in maneuvering the aircraft at near ground level while exposed to hostile gun fire, he rendered invaluable assistance to a United Nation's objective of great significance to the peace efforts of the Free World. Major *Asbury's* exceptional ability as an aviator and outstanding performance of duty in this perilous situation reflect the utmost credit upon himself and the United States Army.

Captain *Roy A. Hudson*, , Transportation Corps, United States Army, as a member of the Office of the United States Army Attache, Leopoldville, Republic of the Congo, distinguished himself by heroism while participating in aerial flight in the Republic of the Congo during the period 2 February to 8 February 1964. As Co-pilot of an Army U8D aircraft, Captain *Hudson* demonstrated unique flying ability and fortitude in the performance of numerous and extremely hazardous evacuation missions in support of United

Nations operations following an uprising in the Republic of the Congo. With full knowledge of several fatalities, he displayed complete disregard for his own personal safety and skillfully participated in surveillance flights into the interior to locate isolated religious missions and call for helicopter and small aircraft to the danger sites for the evacuation of people who lives were in jeopardy. Through his whole-hearted efforts, courage, and assistance to the pilot while the aircraft was maneuvered at near ground level with exposure to hostile gun fire, he rendered invaluable assistance to a United Nations objective of great significance to the peace efforts of the Free World. Captain *Hudson's* exceptional ability as an aviator and outstanding performance of duty in this perilous situation reflect the utmost credit upon himself and the United States Army.

Staff Sergeant *Bobby E. Tucker*, , United States Army, as a member of the Office of the United States Army Attache, Leopoldville, Republic of the Congo, distinguished himself by heroism while participating in aerial flight in the Republic of the Congo during the period 2 February to 8 February 1964. As Radioman on an Army U8D aircraft, Sergeant *Tucker* demonstrated unique professional ability and fortitude in the performance of numerous and extremely hazardous evacuation missions in support of United Nations operations following an uprising in the Republic of the Congo. With full knowledge of several fatalities, he displayed complete disregard for his own personal safety and unhesitatingly participated in surveillance flights into the interior to locate isolated religious missions and call for helicopter and small aircraft to the danger sites for the evacuation of people whose lives were in jeopardy. Through his wholehearted efforts, courage, and assistance to the pilots while the aircraft was maneuvered at near ground level with exposure to hostile gun fire, he rendered invaluable assistance to a United Nations objective of great significance to the peace efforts of the Free World. Sergeant *Tucker's* exceptional professional competence and outstanding performance of duty in the perilous situation reflect the utmost credit upon himself and the United States Army.
