Effective 1 August 1964, the U.S. Army Section, Permanent Working Secretariat, State-Defense Military Information Control Committee is redesignated the U.S. Army Section, Secretariat, United States Military Information Control Committee (SF-1300).
- 2. Above redesignation is necessitated by a change in unit title in Document #MIC 206/29, 1 August 1964, subject: Policy Governing the Disclosure of Classified Military Information to Foreign Governments and International Organizations, issued by the Departments of State and Defense Military Information Control Committee.
