- I_U.S. ARMY INTELLIGENCE CORPS COMMAND. Effective 1 July 1965, the U.S. Army Intelligence Corps Command, Fort Holabird, Md., is redesignated the U.S. Army Intelligence Command (USAINTC).
- II_U.S. ARMY ADMINISTRATIVE SURVEY DETACHMENT. Effective 1 July 1965, the U.S. Army Administrative Survey Detachment is established at Fort Holabird, Md., as a class II activity under the jurisdiction of the Assistant Chief of Staff for Intelligence, Headquarters, Department of the Army. Concurrently, all Intelligence Civilian Career Program functions, personnel, funds, records, and equipment are transferred to the U.S. Army Administrative Survey Detachment from the U.S. Army Intelligence Corps Command.
- III_U.S. ARMY INTELLIGENCE MATERIEL SUPPORT OFFICE. Effective 1 July 1965, the U.S. Army Intelligence Materiel Support Office is established at Fort Holabird, Md., as a class II activity under the jurisdiction of the Assistant Chief of Staff for Intelligence, Headquarters, Department of the Army. Concurrently, all intelligence equipment supply functions, personnel, funds, records, and equipment are transferred to the U.S. Army Intelligence Materiel Support Office from the U.S. Army Intelligence Corps Command.
- IV_FORT LAWTON, WASH. Effective 1 July 1965, Fort Lawton, Wash., a class I installation under the jurisdiction of the Commanding General, Sixth U.S. Army, is redesignated a class I subinstallation of Fort Lewis, Wash., a class I installation under the jurisdiction of the Commanding General, Sixth U.S. Army.
- V_PASADENA AREA SUPPORT CENTER, CALIF. Effective 30 June 1965, the Pasadena Area Support Center, a class I subinstallation of Fort MacArthur, Calif., is discontinued as a Department of the Army installation.
- VI_ELWOOD UNIT (ELWOOD ORDNANCE PLANT) OF THE JOLIET ARMY AMMUNITION PLANT, ILL. Effective 30 June 1965, the Elwood Unit of Joliet Army Ammunition Plant, Ill., a class II installation under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is placed in an inactive status.
- VII_ROTC UNIT AT THE UNIVERSITY OF MISSOURI, CO-LUMBIA, MO. Effective the beginning of the 1965-66 school year, the Artillery Branch Materiel ROTC unit at the University of Missouri, Columbia, Mo., is converted to a General Military Science ROTC unit.
