I..DIRECTOR OF CIVILIAN MARKSMANSHIP. *Effective 2 August 1965*, Col. Merle R. Preble, GS, USA, formerly holding titles of Director of Civilian Marksmanship and Executive Officer, National Board for the Promotion of Rifle Practice, is designated as Director of Civilian Marksmanship, and member of the National Board for the Promotion of Rifle Practice.

II..NATIONAL BOARD FOR THE PROMOTION OF RIFLE PRACTICE. 1. *Effective 2 August 1965*, Lt. Col. C. J. Shaffer, GS, USA, formerly holding title of Assistant Executive Officer, National Board for the Promotion of Rifle Practice, is designated as Executive Officer, National Board for the Promotion of Rifle Practice.

2. *Effective 25 August 1965*, the Honorable David E. McGiffert, Under Secretary of the Army, is announced as President of the National Board for the Promotion of Rifle Practice, vice the Honorable Edmund T. Pratt, Jr.

III..PORT OF WHITTIER, ALASKA. *Effective 13 October 1964*, the Port of Whittier, Alaska, was discontinued as a Department of the Army installation.

IV..FORT NIAGARA, N.Y. *Effective 31 August 1964*, Fort Niagara, N.Y., was discontinued as a Department of the Army installation.

V..BOSTON PROCUREMENT DISTRICT, U.S. ARMY. *Effective 31 October 1965*, the Boston Procurement District, U.S. Army, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, and located at Boston Army Base, Boston, Mass., is discontinued.

VI..CLEVELAND PROCUREMENT DISTRICT, U.S. ARMY. *Effective 30 September 1965*, the Cleveland Procurement District, U.S. Army, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, and located at 1367 East 6th Street, Cleveland, Ohio, is discontinued.

VII..WARRIOR OF THE PACIFIC TEAM COMPETITION. 1. In accordance with paragraph 8, AR 145-395, the annual Warrior of the Pacific rifle competition was conducted at General Military Science ROTC training camps. Utah State University, Logan, Utah, is announced as the winner of the Warrior of the Pacific trophy for the year 1965. Average score per man was 56.53.

2. The Commanding General, 6th U.S. Army will make necessary arrangements for shipping the Warrior of the Pacific trophy, now in the possession of Seattle University, Seattle, Wash.
