- I_FORCE PLANNING AND ANALYSIS OFFICE. 1. Effective 21 February 1966, the Force Planning and Analysis Office is established in the Office of the Chief of Staff, United States Army (TD CS 8525-04).
- 2. The Director of the Force Planning and Analysis Office advises the Secretary of the Army and the Chief of Staff on matters pertaining to integration of Department of the Army requirements for force structure, manpower, material, and readiness; and his office serves as a contact point for information required by outside agencies concerning these subjects.
- II_MERITORIOUS UNIT COMMENDATION. By direction of the Secretary of the Army, under the provisions of paragraph 203, AR 672-5-1, the Meritorious Unit Commendation is awarded to the following unit of the United States Army for exceptionally meritorious achievement in the performance of outstanding service during the period indicated:

The citation reads as follows:

DETACHMENT "J", 3d RADIO RESEARCH UNIT, MILITARY ASSISTANCE COMMAND, VIETNAM, distinguished itself by exceptionally meritorious conduct in the performance of outstanding services in support of the United States effort in the Republic of Vietnam, during the period July 1964 and August 1964. The members of this unit demonstrated fortitude, professional skill, and devotion to duty in providing essential and timely assistance to Government officials, to the Commander of the United States Military Assistance Command, Vietnam, and to other Services of the Armed Forces of the United States. Despite the hazardous situations and hostile activities alien to conventional military operations, the members of this Detachment successfully completed difficult tasks through their team spirit and perseverance. Although constantly exposed to unusual operating conditions, the participating elements provided invaluable support to the joint services effort and contributed in great measure to the success of military operations in Southeast Asia. The loyalty, courage, determination, and espirit de corps displayed by the members of DETACHMENT "J", 3d RADIO RESEARCH UNIT, MILITARY ASSISTANCE COMMAND, VIETNAM, reflect the utmost credit upon themselves and the Armed Forces of the United States.

- V_UNITED STATES ARMY COURIER SERVICE HEADQUARTERS. Section I, General Orders 1, 1966, is amended to read: "UNITED STATES ARMY COURIER SERVICE. Effective 15 January 1966, the United States Army Courier Service (AG-4001-00) is organized as a class II activity under the jurisdiction of The Adjutant General, with Headquarters at Washington, D.C."
- VI_UNITED STATES ARMY COURIER TRANSFER STATIONS. Section II, General Orders 1, 1966, is amended to read: "UNITED STATES ARMY COURIER STATIONS. a. Effective 15 January 1966, the following United States Army Courier Stations, together with their functions, personnel, records, and equipment, are transferred from commands indicated and established as subordinate activities of the United States Army Courier Service, a class II activity under the jurisdiction of The Adjutant General:

VII._NATIONAL AGENCY CHECK CENTER. Effective 1 March 1966, the National Agency Check Center (NACC) is established as a class II activity under the jurisdiction of the Assistant Chief of Staff for Intelligence, Department of the Army, with station at Fort Holabird, Maryland, 21219, a class I installation under the jurisdiction of the Commanding General, First U.S. Army. The mission of this activity is to conduct National Agency checks for all Department of Defense components and notify authorized requesters of the results.

VIII_ROTC UNIT AT NORWICH UNIVERSITY, NORTHFIELD, VERMONT. Effective 1 September 1966, the Engineer, Signal, and Armor Branch Material ROTC units at Norwich University, Northfield, Vermont, are converted to a General Military Science ROTC Unit.
