I_NATIONAL BOARD FOR THE PROMOTION OF RIFLE PRAC-TICE. DA General Orders 14, 1966, is amended as follows:

Effective 26 July 1966, Major General C. P. Brown, GS, USA, is announced as a member of the National Board for the Promotion of Rifle Practice, representing the Office of the Director of the Army Budget, Department of the Army, vice Major General B. F. Taylor, GS, USA.

II_CAMP GARY, TEXAS. Effective 14 February 1966, Camp Gary, Texas, a class I installation under the jurisdiction of the Commanding General, Fourth U.S. Army, was discontinued as a Department of the Army installation.
