- I_U.S. ARMY NIKE-X SYSTEM OFFICE. 1. Effective 15 October 1966, the U.S. Army NIKE-X System Office with station at Washington, D.C., is established as a class II activity under the supervision and command of the NIKE-X System Manager. The incumbent Chief of Research and Development, Department of the Army, in addition to his other duties, is designated the NIKE-X System Manager, (Acting) (NXSM,(A)).
- 2. Effective concurrently, the NIKE-X Project Office, a class II activity under the command of the U.S. Army Materiel Command, is placed under the operational control of the NXSM,(A).
- 3. The NXSM,(A) is established as the single point of contact within the Department of the Army for the coordination and direction of all activities pertaining to the NIKE-X System. He is responsible for, and is delegated authority to, exercise executive authority for the Department of the Army over the planning, direction, and control of the approved NIKE-X program and to insure accomplishment of the necessary planning required to produce and deploy the weapon system if and when a production decision is made.
- II_UNITED STATES ARMY RECRUITING COMMAND. So much of paragraph 2, section I, DA General Orders 28, 1966, as pertains to Fort Amador, Canal Zone, is rescinded.
- III_ROTC UNITS. DA General Orders 25, 1966, is amended as follows:
- 1. Miller School of Albemarle, Miller School, Virginia. So much of paragraph 1, DA General Orders 25, 1966, as pertains to the establishment of a class MI Junior ROTC unit at Miller School of Albemarle, Miller School, Virginia, is rescinded. Effective 1 July 1966, the NDCC unit at Miller School of Albemarle converted to a class HS Junior ROTC unit.
- 2. Denby High School, Detroit, Michigan. So much of paragraph 2, DA General Orders 25, 1966, as pertains to Denby High School, Detroit, Michigan, is amended to delete the asterisk (*).
- 3. Chattanooga High School, Chattanooga, Tennessee. So much of paragraph 2, DA General Orders 25, 1966, as pertains to Chattanooga High School, Chattanooga, Tennessee, is rescinded. Effective 30 September 1966, the class HS Junior ROTC unit at Chattanooga High School was withdrawn.
