**VI. SOLDIER'S MEDAL.** By direction of the President, under the provisions of the Act of Congress, approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Chief Warrant Officer *Douglas A. Nelson*, , United States Army, while serving as a member of Battery A, 4th Battalion, 62d Artillery, 6th Artillery Group, Fort Bliss, Texas, distinguished himself by heroism on 13 May 1965 at El Paso, Texas, while acting as Traffic Control Officer for a military convoy en route to Fort Bliss, Texas. An automobile, traveling at a high rate of speed, by-passed a line of stopped vehicles and struck a 2½ ton truck that was crossing the highway. Chief Warrant Officer *Nelson* immediately ran to the scene where he found the driver of the automobile pinned between

the steering mechanism and the left front door and in the throes of strangulation. He quickly cleared her breathing passages, then with complete disregard for his own safety and despite the danger of explosion of the smoking vehicle and the intense fumes of the escaping gasoline, he forced open the jammed door and removed the dazed and helpless driver to a place of safety. Chief Warrant Officer *Nelson's* heroic conduct and prompt actions in this hazardous situation are in the highest traditions of the United States Army and reflect great credit upon himself and the military service.

Second Lieutenant *Loren B. Wills*, , Artillery, United States Army, Staff and Faculty Battery, United States Army Artillery and Missile School, Fort Sill, Oklahoma is cited for an act of heroism on 21 February 1966 for his effort in rescuing a stranded amateur mountain climber. Lieutenant *Wills* voluntarily risked his life to rescue a young boy from an inaccessible mountain ledge in the Wichita Mountain Wildlife Refuge. Without thought for his own safety, Lieutenant *Wills* went to the aid of a 17 year old boy, who had been stranded for 18 hours, by making a dangerous climb up Elk Mountain, rappelling to the boy and lowering him to safety. The hazards of the rescue effort were greatly increased by subfreezing temperatures, the area covered with ice and snow, and winds gusting to 30 knots. Unable to use normal safe climbing procedures, Lieutenant *Wills* had to rappel to the freezing boy, knowing that he might fall several hundred feet to certain death. Lieutenant *Wills'* heroic conduct is in the highest tradition of the United States Army and reflects great credit upon himself and the Military Service. (This award supersedes the Army Commendation Medal awarded to Lieutenant *Wills* for heroism on 21 February 1966, as announced in General Orders Number 129, Headquarters, U.S. Army Artillery and Missile Center, Fort Sill, Oklahoma, dated 18 July 1966.)

**VII--AIR MEDAL.** By direction of the President, under the provisions of Executive Order 9158, 11 May 1942, as amended by Executive Order 9242-A, 11 September 1942, an Air Medal (First Oak Leaf Cluster) for heroism while participating in aerial flight is awarded by the Department of the Army to:

Major *Paul R. Medbury*, (then Captain), Infantry, United States Army, distinguished himself by heroic action on 21 November 1963 while serving as a door gunner on a UH-1B helicopter while on combat assault, resupply and aeromedical evacuation missions in the Republic of South Vietnam. Major *Medbury*, learning that a heliborne force was to be deployed against the Viet-Cong in the area of My Tho and Tan Heip and with full knowledge that hostile fire would be encountered, volunteered to perform duty as door gunner throughout the operation. During the initial phases of the combat assault operation, Major *Medbury* was continuously exposed to heavy Viet-Cong fire. Major *Medbury* displayed the highest possible air discipline and courage, in that he continuously fired at the enemy from exposed positions, placing himself outside the helicopter on the skids while airborne to suppress the enemy fire. During the refueling and reloading of ammunition at Tan Heip an urgent request was received to resupply ammunition to a supporting ground element and attempt

rescue and aeromedical evacuation of wounded Vietnamese troops from an outpost under siege. Major *Medbury* volunteered to go as a door gunner to provide much needed relief for the heavily committed air crews. Upon landing, Major *Medbury* departed the helicopter and placed himself in a position to defend the aircraft during off loading of ammunition and the loading of wounded on the helicopter for evacuation. The Viet-Cong were firing from positions within twenty yards from the helicopter. Major *Medbury's* continuous retaliatory fire was instrumental in reducing the accuracy of the Viet-Cong fire to the point that no U.S. crew members were wounded. Major *Medbury* provided suppressive and protective fire during the evacuation by placing himself on the skid of the aircraft with his body screening the wounded from enemy fire, placing their welfare above his own safety. Major *Medbury's* heroic actions directly contributed to the safe and successful conduct of the entire day's missions. His actions reflect great credit upon himself, the command and the United States Army.

**VIII. AIR MEDAL.** By direction of the President, under the provisions of Executive Order 9158, 11 May 1942, as amended by Executive Order 9242-A, 11 September 1942, an Air Medal (Eighth Oak Leaf Cluster) for meritorious achievement while participating in aerial flight is awarded by the Department of the Army to:

Chief Warrant Officer *Kenneth E. Dickey*, , United States Army.

**IX. ARMY COMMENDATION MEDAL.** By direction of the Secretary of the Army, under the provisions of paragraph 33, AR 672-5-1, the Army Commendation Medal with "V" device for heroism is awarded to:

Staff Sergeant *Arthur B. Bengen*, United States Marine Corps,  
distinguished himself by heroism while on operations with a patrol from Camp Anh Son, Khe Sanh, Vietnam, on 20 October 1964. When the Viet Cong ambushed the small patrol which Sergeant *Bengen* was advising, he distinguished himself heroically by immediately establishing a rear guard which prevented the unit from being surprised in the rear, and then moving through heavy fire, went to the assistance of fellow Americans on the patrol. Upon arriving at the front of the patrol, Sergeant *Bengen*, with complete disregard for his own safety, assisted in an assault on the Viet Cong which routed them from their positions suffering two killed and two wounded. This courageous action of Sergeant *Bengen* is a credit to himself, and the United States Marine Corps.
