**I. NATIONAL BOARD FOR THE PROMOTION OF RIFLE PRACTICE.** *Effective 25 March 1967*, Honorable J. Cordell Moore, Assistant Secretary for Mineral Resources, Department of the Interior, is appointed to membership on the National Board for the Promotion of Rifle Practice.

**II. U.S. ARMY AIRCRAFT MAINTENANCE ACTIVITY OF FORT WORTH ARMY DEPOT.** *Effective 1 April 1967*, the U.S. Army Aircraft Maintenance Activity of Fort Worth Army Depot, a Class II activity located at Fort Riley, Kans., under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is redesignated the U.S. Army Aircraft Maintenance Activity, Fort Riley, Kans.

**IV. NATIONAL AGENCY CHECK CENTER, FORT HOLABIRD, MD.** *Effective 1 April 1967*, the National Agency Check Center, a class II activity under the jurisdiction of the Commanding General, U.S. Army Intelligence Command, is redesignated the Department of Defense National Agency Check Center (DODNACC).
