I.—GENERAL COURTS-MARTIAL. The Commanding Officer, Task Force Oregon, APO San Francisco 96374, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial, *effective 20 April 1967*.

II.—U.S. ARMY STRATEGIC COMMUNICATIONS COMMAND, FORT HUACHUCA, ARIZ. *Effective 15 April 1967*, the Headquarters of the U.S. Army Strategic Communications Command, a major field command of the Department of the Army, is relocated from Washington, D.C., to Fort Huachuca, Ariz. 85613.

III.—ERIE ARMY DEPOT, OHIO. *Effective 1 January 1967*, the Erie Army Depot, Ohio, a class II installation under the jurisdiction of the Commanding General, U.S. Army Materiel Command was discontinued.

IV.—U.S. ARMY LOGISTICS DOCTRINE AND SYSTEMS AGENCY. So much of section IV, DA General Orders 4, 1967, as reads "Logistics Doctrine and Systems Agency" is amended to read "U.S. Army Logistics Doctrine and Systems Agency."

V.—ROTC UNITS. *Effective 1 July 1967*, class MI Junior ROTC units are established at the following essentially military schools under the provisions of AR 145-10:

Peekskill Military Academy, Peekskill, N.Y.
Staunton Military Academy, Staunton, Va.
