**I. ARMY INTELLIGENCE AND SECURITY BRANCH.** *Effective 1 July 1967*, Army Intelligence and Security Branch, a basic branch of the Army, is redesignated as Military Intelligence.

**II. FORT HUACHUCA, ARIZ.** *Effective 1 July 1967*, Fort Huachuca, Ariz., is redesignated from a class II installation under the jurisdiction of the Commanding General, U.S. Army Materiel Command to a class II installation under the jurisdiction of the Commanding General, U.S. Army Strategic Communications Command.

**III. FORT SLOCUM, N.Y.** *Effective 11 May 1967*, Fort Slocum, N.Y., a class I installation under the jurisdiction of the Commanding General, 1st U.S. Army, was discontinued as a Department of the Army installation.

**IV. WATERTOWN ARSENAL.** *Effective 30 June 1967*, the Watertown Arsenal, Watertown, Mass., a class II installation under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is placed in an inactive status and concurrently redesignated a class II activity.

**V. ARMY MATERIALS AND MECHANICS RESEARCH CENTER.** *Effective 1 July 1967*, the Army Materials and Mechanics Research Center, Watertown, Mass., is established as a class II installation under the jurisdiction of the Commanding General, U.S. Army Materiel Command.

**VI. U.S. ARMY MATERIALS RESEARCH AGENCY.** *Effective 1 July 1967*, the U.S. Army Materials Research Agency, Watertown, Mass., a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is discontinued and all of its assigned functions, personnel, funds, records, and facilities transferred to the Army Materials and Mechanics Research Center.

**VII. ROTC UNITS AT MILITARY SCHOOLS.** In accordance with paragraph 9c(2), AR 145-25, ROTC units at the following named essentially military schools are designated as honor ROTC units for the school year 1966-67. This rating is *effective only for academic year 1967-68*:
