- I\_\_SENTINEL SYSTEM ORGANIZATION. Effective 15 November 1967, the SENTINEL System Organization is established at Washington, D.C., and will consist of the following

  - U.S. Army SENTINEL System Office.
     U.S. Army SENTINEL System Command.
  - 3. U.S. Army SENTINEL System Evaluation Agency.

II\_SENTINEL SYSTEM MANAGER. 1. Effective 15 November 1967 the SENTINEL System Manager (SENSM) is established within the Office of the Chief of Staff, U.S. Army, as the principal assistant and staff advisor to the Chief of Staff and the Secretary of the Army for all matters pertaining to the SENTINEL program. The SENTINEL System Manager, within the instructions of the Chief of Staff, will exercise Department of the Army executive authority over the approved SENTINEL program and the resources made available for its accomplishment, and will exercise staff supervision over all Army staff elements and participating organizations for planning, direction, and control of the SENTINEL program.

2. The SENTINEL System Manager is designated the Commanding Offi-

cer of the SENTINEL System Organization and will exercise command authority over the SENTINEL System activities established for management of the SENTINEL program, with the exception of the National Range mission of the Kwajalein Test Site, which will be performed under the guidance and direction of the Chief of Research and Development, Headquarters, Department of the Army. The mission of the SENTINEL System Manager is to develop and, when so directed, assure timely, effective deployment of the SENTINEL Ballistic Missile Defense System and provide a single point of contact within the Department of the Army for the coordination and direction of all activities pertaining to the SENTINEL system.

III\_U.S. ARMY SENTINEL SYSTEM OFFICE. 1. Effective 15 November 1967, the U.S. Army SENTINEL System Office (SENSO) is established at Washington, D.C., as an element of the Office of the Chief of Staff, U.S. Army, to assist the SENTINEL System Manager in the exercise of his responsibilities.

2. Concurrently, the NIKE-X System Office, a class II activity under the jurisdiction of the NIKE-X System Manager is discontinued and its personnel and resources transferred to the U.S. Army SENTINEL System Office.

IV\_\_U.S. ARMY SENTINEL SYSTEM COMMAND. 1. Effective 15 November 1967, the U.S. Army SENTINEL System Command (SENSCOM) is established at Huntsville, Ala., as a class II activity under the supervision and command of the SENTINEL System Manager for accomplishment of the development, acquisition, and installation of the SENTINEL system.

2. Concurrently, the NIKE-X Project Office, a class I activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command is discontinued and its personnel and resources transferred to the U.S. Army

SENTINEL System Command.

- 3. The Commanding General, U.S. Army SENTINEL System Command, is designated a Deputy SENTINEL System Manager. He will perform his mission assignment for execution of the approved SENTINEL program under the guidance and direction of the SENTINEL System Manager. Powers and authorities delegated to the Commanding General, U.S. Army SENTINEL System Command will be as prescribed by the SENTINEL System Manager. He will exercise command over tactical SENTINEL sites during the activation phase, until acceptance of the operational site by the Commanding General, U.S. Army Aid Defense Command, as well as supervision for integration and coordination over co-located elements of the Army commands and agencies in accomplishment of the total SENTINEL program. He will command the Kwajalein Test Site, a National Range facility, under the guidance and direction of the Chief of Research and Development, Headquarters, Department of the Army, with regard to the National Range mission.
- V\_U.S. ARMY SENTINEL SYSTEM EVALUATION AGENCY. 1. Effective 15 November 1967, the U.S. Army Sentinel System Evaluation Agency (SENSEA) is established as a class II activity, at White Sands Missile Range, New Mexico, under the supervision and command of the SENTINEL System Manager to provide a single organization for performing evaluation of the SENTINEL System independent of the U.S. Army SENTINEL System Command and its contractor organization. The Commanding Officer, U.S. Army SENTINEL System Evaluation Agency is responsible for performing or participating in testing necessary to support an independent evaluation program responsive to user requirements.

2. Concurrently, the U.S. Army NIKE-X Engineering/Service Test Office, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command is discontinued and its personnel and resources transferred to the U.S. Army SENTINEL System Evaluation Agency.

- VI\_KWAJALEIN TEST SITE. Effective 15 November 1967, the Kwajalein Test Site, a National Range in the Marshall Islands of the Pacific, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, is transferred to the command of the Commanding General, U.S. Army SENTINEL System Command, and designated a subordinate activity of that command.
- VII\_GENERAL COURTS-MARTIAL. The Commanding Officer, SENTINEL System Organization, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6) to convene general courts-martial, effective 15 November 1967.
- VIII\_\_GENERAL COURTS-MARTIAL. The Commanding Officer, U.S. Army SENTINEL System Command, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6) to convene general courts-martial, effective 15 November 1967.
