I--GENERAL COURTS-MARTIAL. The Commanding Officer, U.S. Army Infantry Center and Fort Benning, Fort Benning, Ga., is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial, *effective 1 December 1967*.

II--GENERAL COURTS-MARTIAL. The Commanding Officer, U.S. Army School/Training Center and Fort Gordon, Fort Gordon, Ga., is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial, *effective 1 December 1967*.
