**I.—GENERAL COURTS-MARTIAL.** The Commanding Officer, U.S. Army Training Center, Infantry, and Fort Dix, Fort Dix, New Jersey, is designated by the Secretary of the Army, pursuant to Article 22(a)(6), Uniform Code of Military Justice, to convene general courts-martial, *effective 17 April 1968*.

**II.—GENERAL COURTS-MARTIAL.** The Commanding Officer, Engineer Troops Vietnam (Provisional), APO San Francisco 96491, is designated by the Secretary of the Army pursuant to Article 22(a)(6), Uniform Code of Military Justice, to convene general courts-martial, *effective 29 March 1968*.

**III.—GENERAL COURTS-MARTIAL.** The Commanding Officer, U.S. Army Correctional Training Facility, Fort Riley, Kansas, is designated by the Secretary of the Army, pursuant to Article 22(a)(6), Uniform Code of Military Justice, to convene general courts-martial, *effective 1 April 1968*.

**IV.—MILITARY TRAFFIC MANAGEMENT AND TERMINAL SERVICE AREAS.** The Military Traffic Management and Terminal Service Areas, as established by DA General Orders 12, 1965 are realigned as indicated, *effective 20 June 1968*:

1. The Eastern Area, MTMTS, with headquarters at Brooklyn, New York, a class II activity, under the jurisdiction of the Commander, Military Traffic Management and Terminal Service will consist of the following States:
