II. SILVER STAR. 1. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded to:

Specialist Four *Bryan K. Grigsby*, RA12885476, United States Army, distinguished himself by heroic action in connection with military operations against an armed hostile force in the Republic of Vietnam. While serving as a

sound specialist and still photographer for the Vietnam-based element of the United States Army Special Photographic Detachment, Pacific, Specialist *Grigsby* participated in the pictorial coverage of the heavy fighting on the outskirts of Saigon on 6 May 1968. On that day Specialist *Grigsby* accompanied elements of the 1st Army of the Republic of Vietnam Airborne Division as they advanced against an estimated North Vietnam Army/Viet Cong battalion near Tan Son Nhut Air Base. Advancing with the vanguard of Army of the Republic of Vietnam forces into withering enemy small arms fire, Specialist *Grigsby* began to record the battle as it raged about him. Displaying disregard for his personal welfare he repeatedly braved the enemy fire to move to areas where the fiercest fighting was taking place. At one point during the battle Specialist *Grigsby* witnessed a companion photographer wounded and knocked to the ground by enemy shrapnel. Ignoring his personal safety, Specialist *Grigsby* dashed across some seventy-five meters of open ground to where his comrade lay, pulled the wounded man to comparative safety, and administered emergency first aid. Then once again he returned to the battle area to continue recording the fighting. Throughout this vicious battle, Specialist *Grigsby* again and again displayed aggressiveness, professionalism, and almost incredible courage in the face of the enemy. His actions prevented the possibility of further wounds to his comrade. His tenacious insistence on the accomplishment of the mission resulted in the documentation of the action for the Department of the Army. His outstanding devotion to duty and personal bravery are in keeping with the highest traditions of the military service and reflects great credit upon himself, his unit, and the United States Army.

2. By direction of the President, under the provisions of the Act of Congress approved 9 July 1918, a Silver Star for gallantry in action is awarded to:

Major *Sammy E. Radow*, O888438, Infantry, United States Army, distinguished himself by gallantry in action near Changnyong, Korea on 16 September 1950, while serving as Commanding Officer, Company M, 23d Infantry Regiment, 2d Infantry Division. On this date Major *Radow* was in command of Company M, 23d Infantry Regiment, while that unit was participating in the general attack upon enemy positions along the Nakdong River. Throughout the day, Major *Radow* voluntarily remained with the leading assault elements of his unit in order to direct fire of his supporting weapons with greater effect. When the radio operator was wounded, Major *Radow* remained in an exposed position, under intense enemy fire, and personally operated the radio until another operator was sent forward. His heroic and aggressive leadership throughout this action was a source of inspiration to all members of his company and contributed greatly to the success of his battalion in its offensive. Major *Radow's* gallant conduct is in the highest traditions of the military service and reflects great credit upon himself, his unit and the United States Army.

VII--SOLDIER'S MEDAL. 1. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Sergeant First Class *Ralph Garcia*, RA25971042, United States Army, who distinguished himself with an act of heroism in the saving of human life in La Paz, Bolivia, on 29 June 1968. Returning to his quarters with his wife and another couple, Sergeant *Garcia* encountered a blazing automobile in which the driver and front seat passenger were trapped and burning. Bystanders were too frightened or confused to act. Ignoring warnings, Sergeant *Garcia*, with complete disregard for his own safety, approached the flaming wreckage

and discovered a passenger in the rear of the automobile. Failing to gain access to the automobile from the safest area, Sergeant *Garcia* entered into a confined space between the wreckage and a solid retaining wall and managed to gain access. Thoughtless of the position of extreme danger into which he had placed himself, Sergeant *Garcia* managed to effect the rescue of a surviving victim and initiate her evacuation. Sergeant *Garcia's* actions are in the highest traditions of self sacrifice and humanity and reflect highest credit upon himself, his training as a United States soldier, and the United States of America.

2. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Staff Sergeant *Ervin A. Goerd*, NG55559613, United States Army, who distinguished himself by courageous conduct, giving no thought to his own safety, and at the risk of his life, on 1 July 1968. While serving as Platoon Sergeant with his unit during the Annual Field Training Period, 1968, Sergeant *Goerd* was present when, during tank refueling operations, gasoline became ignited and flames quickly enveloped the vehicle being serviced. The tank commander, standing in close proximity to his tank, was set ablaze by the exploding gasoline, and fell to the ground in a flaming pool. With the tank ablaze, and the truck from which the tank had been receiving its fuel standing adjacent to the burning tank and in momentary danger of also exploding, Sergeant *Goerd*, with complete disregard for his own personal safety, and knowing full well the imminent dangers involved, rushed headlong in the blazing fuel and pulled the injured tank commander clear of the roaring flames. Using his own body and his bare hands, Sergeant *Goerd* extinguished the flames which covered the man's body. In the performance of this heroic act, Sergeant *Goerd* himself sustained exceedingly painful injuries, but his instantaneous response in a highly critical situation, coupled with his courageous action, undoubtedly resulted in saving the tank commander's life. His exemplary conduct and heroic actions speak most eloquently of himself, the unit of which he is a member, the State of Minnesota, and the National Guard which he so heroically served.

3. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Specialist Five *Theodore A. Place*, RA12492473, United States Army, who distinguished himself by heroism on 12 March 1968 while assigned to 38th Military Police Detachment, United States Army, Hawaii. At approximately 1240 hours, Specialist *Place* was having lunch in his quarters at Schofield Barracks when he heard what sounded like gunshots outside the adjoining quarters. He ran outside to investigate and saw a soldier standing on the sidewalk with a .45 caliber pistol in his hand and a woman lying on the ground adjacent to the sidewalk in the parking lot. He quickly evaluated the situation and realized that as long as the man remained armed, there could be further deaths or serious injury to others. While other military personnel in the immediate area fled for cover, Specialist *Place* although unarmed, without hesitancy and with complete disregard for his own safety, approached the soldier, disarmed him and took him into custody in a cool and highly professional manner. The soldier, who was later charged and convicted of murder, had fired the weapon four times, each round striking the victim. The weapon had one round in the cham-

ber and two rounds remaining in the magazine when Specialist *Place* disarmed the murder suspect. Specialist *Place*, who is a clerk typist and not a trained military policeman, displayed sincere devotion to duty to the extent of risking his life to apprehend the armed and suspected murderer. His courageous deed, which is above and beyond that required for the functions of his duty, is in keeping with the highest traditions of the military service and reflects great credit upon himself, the Military Police Corps, and the United States Army.

VIII--BRONZE STAR MEDAL. By direction of the President, under the provisions of Executive Order 9419, 4 February 1944, a Bronze Star Medal with "V" device (Second Oak Leaf Cluster) for heroic achievement in connection with military operations against hostile forces is posthumously awarded to:

Corporal *William R. Willauer, Jr.*, 14117551, United States Army, who distinguished himself by heroism in connection with military operations against an armed enemy in Luxembourg, France, on 16 December 1944 while serving as a member of Company F, 12th Infantry, 4th Infantry Division. Corporal *Willauer* volunteered to drive a jeep through a heavily machinegunned area in an attempt to make contact with the Company E outpost. After making contact with Company E and delivering a radio, the enemy launched a heavy artillery assault knocking out communications between Company E and battalion headquarters. Realizing the seriousness of the attack and the probability of battalion headquarters being caught without warning and prior planning, Corporal *Willauer* volunteered to risk his life in an attempt to warn battalion headquarters of the enemy situation. Again, he voluntarily drove a jeep through the heavily machinegunned area. However, before he could reach battalion headquarters he was mortally wounded by the enemy machinegun fire. Corporal *Willauer's* exceptional courage, selfless concern for his fellow soldiers and extreme devotion to duty are in keeping with the highest traditions of the military service and reflects great credit upon himself, his unit, and the United States Army.

IX--BRONZE STAR MEDAL. By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal with "V" device for heroic achievement in connection with military operations against hostile forces is awarded to:

Captain *Robert T. Beidleman*, O5318129 (then First Lieutenant), Infantry, United States Army, who distinguished himself by heroism in connection with military operations against a hostile force in the Republic of Vietnam on 8 November 1965 while serving as a rifle platoon leader in "War Zone D." At approximately 1000 hours Captain *Beidleman* was issuing an attack order when his platoon was engaged by hostile mortar and small arms fire. On the initial burst of fire Captain *Beidleman* was wounded in the right side. Immediately he left his command post, further exposing himself to the hostile weapons fire, and personally influenced the action of his platoon. Even though wounded a second time during the vicious attack by the Viet Cong, his dynamic and courageous leadership led to the eventual defeat of the Viet Cong in his area. Captain *Beidleman's* unimpeachable valor in close combat against a numerically superior hostile force was in keeping with the highest traditions of the military service and reflects great credit upon himself, his unit, and the United States Army.

Staff Sergeant *Harold H. Dreblow*, RA 24631193, United States Army, who distinguished himself by heroism while taking part in a joint Vietnamese/

American Special Forces long reconnaissance patrol deep in Viet Cong-controlled territory. On the 19th of June 1965 the patrol located a battalion-sized Viet Cong unit. To determine the extent of their positions Sergeant *Dreblow* and his Vietnamese counterpart moved in close to the Viet Cong to plot their exact positions. Crawling along the ground they worked to within 25 meters of the Viet Cong. Upon his return Sergeant *Dreblow* reported what he had seen and because of his judgment the airstrike which followed caused a great number of casualties to the Viet Cong. For the following two days Sergeant *Dreblow*, along with the patrol, was in constant contact with the Viet Cong, continuing to call airstrikes upon the enemy. On the 21st of June 1965 the patrol worked its way to a landing zone for exfiltration. When the helicopter started to land for the patrol the Viet Cong launched an attack upon them and the chopper. Again, as during the last two days, Sergeant *Dreblow*, without regard for his own safety, fought a rear action trying to give the team time to board safely, he himself being one of the last aboard. During those few days of action and constant contact with a far superior Viet Cong force, Sergeant *Dreblow* was a major deciding factor in the success of the airstrikes which killed or wounded 300 or more Viet Cong. Sergeant *Dreblow*'s actions were indeed in the finest traditions of the military service and its Special Forces, and reflect great credit upon himself and the United States Army.

X--BRONZE STAR MEDAL. By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal for meritorious achievement in connection with military operations against hostile forces is awarded to:

Major *Howard F. Stone*, O72248, Infantry, United States Army. On 8 January 1966.

With complete disregard for his own safety, Sergeant *Smith* again infiltrated through the enemy-infested area to retrieve the radio. The following morning the radio Sergeant *Smith* had retrieved was used to call in accurate and deadly airstrikes against the enemy and evacuate the team. Sergeant *Smith's* outstanding display of aggressiveness, devotion to duty, and personal bravery is in keeping with the highest standards of the military service and reflects great credit upon himself, his unit, and the United States Army.
