**I.—SILVER STAR.** By direction of the President, under the provisions of the act of Congress, approved 9 July 1918, a Silver Star for gallantry in action is awarded to:

Private First Class *Thuong Van Dong*, 59120723, Army of the Republic of Vietnam, who distinguished himself by gallantry in action while engaged in military operations in Vietnam in January 1965. As an Assistant to a United States Assistant Battalion Advisor, Private *Dong* was engaged in a battalion-sized search-and-destroy operation in the An Lao Valley when the lead element was subjected to heavy hostile gunfire as it crossed an open, sandy, river beach. When the Battalion Advisor was severely wounded, Private *Dong* raced to his side and, using his own body and pack, placed himself in front of the wounded American advisor, directly in the line of fire. Although the insurgents' gunfire continued, he remained in this position for 1 hour, shielding his wounded counterpart and alternating between administering first aid to the injured officer and attempting to suppress the hostile action by using his own weapon. He then again exposed himself to the intense gunfire by assisting the wounded American to the evacuation helicopter. Through his indomitable courage, fortitude, and willingness to protect a fallen comrade at the risk of his own safety, he prevented further possible injury to the wounded United States advisor. Private *Dong's* conspicuous gallantry is in the highest traditions of the military service and reflects great credit upon himself and the armed forces of his country.

**II.—LEGION OF MERIT.** By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1953, the Legion of Merit (Degree of Officer) (Second Award) for exceptionally meritorious conduct in the performance of outstanding service is awarded posthumously to:

Major General *Jose Theophilo De Arruda*, Army of Brazil. August 1959 to May 1961.

**III.—LEGION OF MERIT.** By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1953, the Legion of Merit (Degree of Officer) for exceptionally meritorious conduct in the performance of outstanding service is awarded posthumously to:

Colonel *Tran Hoang Quan*, H2A101382, Army of the Republic of Vietnam. November 1963 to March 1964.

**IV.—LEGION OF MERIT. 1.** By direction of the President, under the provisions of the Act of Congress approved 20 July 1942, and Executive Order 10600, 15 March 1955, the Legion of Merit (Degree of Chief Commander) for

exceptionally meritorious conduct in the performance of outstanding service is awarded to:

**V--BRONZE STAR MEDAL.** By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, the Bronze Star Medal with "V" device for heroic achievement in connection with military operations against hostile forces is awarded posthumously to:

Captain *Nguyen Thanh Nguyen*, Army of the Republic of Vietnam, who distinguished himself by heroic achievement while engaged in military operations against an opposing armed force in March 1964, in Phu Yen Province, Republic of Vietnam. Captain *Nguyen* was participating with a United States Army military advisor in a military operation against the Viet Cong when the American advisor was wounded on the battlefield. With complete disregard for his own personal safety, Captain *Nguyen* rushed through a hail of enemy small arms and automatic weapons fire, succeeded in reaching the wounded man, and dragged him to a defiladed position. By his fortitude, courageous actions, and deep concern for his American counterpart, he enhanced the comradeship between the military members of both nations and performed an act of heroism which was of mutual benefit to his country and to the United States. Captain *Nguyen's* heroic conduct reflects distinct credit upon himself and the Army of the Republic of Vietnam.
