I\_DISTINGUISHED SERVICE CROSS. By direction of the President, under the provisions of the Act of Congress approved 25 July 1963, the Distinguished Service Cross for extraordinary heroism in action is awarded, posthumously, to:

First Lieutenant Robert S. Hutchinson II, 05337729 (then Second Lieutenant), Infantry, United States Army, distinguished himself by extraordinary heroism on 16 February 1968 while serving with Company A, 2d Battalion (Mechanized), 22d Infantry, 25th Infantry Division in the Republic of Vietnam. On this date, elements of Company A were conducting a reconnaissancein-force operation in the vicinity of Tay Ninh when Lieutenant Hutchinson's platoon came under attack by antitank rockets, rifle grenades, automatic weapons and small arms fire from a Viet Cong battalion positioned in well-fortified bunkers. Without hesitation, he immediately began directing the fire of his men on the enemy, and, after an armored personnel carrier had crashed through a brick wall in front of the enemy positions, he led his men through the opening in an assault against the insurgents. When heavy casualties were sustained, Licutenant Hutchinson withdrew his men to regroup, covering their movement with his own fire. As the Viet Cong began a counterassault, he remained in his exposed position and fired into the charging Viet Cong ranks. Even though an enemy rocket exploded near him, Lieutenant Hutchinson continued to hold his position until his men had cleared the area. After supervising evacuation of the wounded, he again reorganized his men for another assault on the Viet Cong positions. While closing on the enemy, he was mortally wounded by automatic weapons fire. His courageous actions and determination were responsible for the eventual defeat of the fanatical enemy force. Lieutenant Hutchinson's extraordinary heroism was in keeping with the highest traditions of the military service and reflects great credit upon himself, his unit and the United States Army.

II\_\_DISTINGUISHED SERVICE CROSS. By direction of the President, under the provisions of the Act of Congress approved 25 July 1963, the Dis-

tinguished Service Cross for extraordinary heroism in action against an enemy is awarded posthumously to:

Captain Gregory P. Kernahan, Jr., OF100823, Corps of Engineers, United States Army, distinguished himself by extraordinary heroism in action while serving as a Convoy Commander near Pleiku and Kontum, Republic of Vietnam. on 6 March 1968. Captain Kernahan's unit was ambushed by a hostile force. His personal courage and inspiring leadership while directing the preparation of the convoy's defense and care for the wounded resulted in a well-organized defensive action. After his vehicle had completely cleared the kill zone, Captain Kernahan voluntarily returned to aid his comrades. He appeared to be oblivious of the intense enemy fire and knew that moving from vehicle to vehicle was extremely dangerous. Leaving the shelter of a dump truck to reach and aid several wounded men, he himself was wounded by small arms fire. As his own wounds were being treated, he continued to give directions as to how the defense was to be established and instructions for the care of the wounded. Almost an hour passed before the evacuation of the wounded commenced. Captain Kernahan directed this action and insisted on being the last evacuated. As a result, he died before reaching the hospital, Captain Kernahan's extraordinary heroism and intrepidity at the cost of his own life are in the highest traditions of the United States Army and reflects great credit upon himself and the Armed Forces of his country.

III\_DISTINGUISHED SERVICE CROSS. By direction of the President, under the provisions of the Act of Congress approved 25 July 1963, the Distinguished Service Cross for extraordinary heroism in action against an enemy is awarded posthumously to:

Staff Sergeant James W. Liebespeck, RA27551259, United States Army, who distinguished himself by extraordinary heroism while leading his squad on a minesweeping operation near Dau Tieng, Republic of Vietnam, on 21 May 1968. Sergeant Liebespeck was serving as a squad leader in a Combat Engineer company and was sweeping a heavily traveled main supply route to allow resupply convoys to move through. In the process of the minesweep Sergeant Liebespeck found a large piece of metal. He checked for boobytraps and then raised the metal, exposing and activating a grenade. Sergeant Liebespeck, hearing a warning from a fellow squad-member, dropped the piece of metal. Approximately four steps away and nearing safety, Sergeant Liebespeck recognized the danger to his men, turned and ran back to the grenade. As he reached to pick it up the grenade exploded. Through his indomitable courage, complete disregard for his own safety, and profound concern for his fellow soldiers, he averted possible loss of life and injury to the members of his squad. Sergeant Liebespeck's extraordinary heroism was in keeping with the highest traditions of the military service and reflects great credit upon himself and the United States Army.

IV\_DISTINGUISHED SERVICE CROSS. By direction of the President, under the provisions of the Act of Congress approved 25 July 1963, the Distinguished Service Cross for extraordinary heroism in action is awarded, posthumously, to:

Captain Edmund B. Scarborough, OF105268, Infantry, United States Army, distinguished himself by heroism in action on 10 May 1968 while serving as Commanding Officer, Company C, 5th Battalion (Mechanized), 60th Infantry, 9th Infantry Division, in Gia Dinh Province, Republic of Vietnam.

While in contact with an enemy force of battalion strength, Captain Scarborough's company and another company to his front were halted by a devastating crossfire. Captain Scarborough was ordered to pass through the now-beleaguered lead company and maneuver against the enemy's flank. He immediately organized his mechanized assault and positioned himself in an extremely exposed location from which he could control the advance. Although the enemy force immediately engaged the advancing element with antitank rockets, small arms and automatic weapons fire, Captain Scarborough continued to lead his men, direct the fire of all available weapons and maintain the advance. Realizing the psychological value of Captain Scarborough's exceptional leadership, the enemy began to concentrate all of their firepower at his position. Captain Scarborough continued his utter disregard for his personal safety and remained exposed, directing the consolidation and supporting fires until he was fatally wounded by the concentrated enemy fire. As a direct result of Captain Scarborough's courage the enemy lost 26 KIA's, 3 POW's and 7 weapons which were captured. Captain Scarborough's professional competence, grim determination and personal example inspired his men to victory and reflects the utmost credit upon himself and the United States Army.

V--DISTINGUISHED SERVICE CROSS. By direction of the President, under the provisions of the Act of Congress approved 25 July 1963, the Distinguished Service Cross for extraordinary heroism is awarded, posthumously, to:

Corporal Aristides Sosa, US52758743, (then Private First Class), United States Army, distinguished himself by extraordinary heroism on 2 March 1968 while assigned to Company A, 65th Engineer Battalion in the Republic of Vietnam. On this date, Corporal Sosa was part of a four-man engineer team accompanying an infantry unit on a reconnaissance-in-force operation in the vicinity of Lai Theiu when the friendly force came under attack from Claymore mines, automatic weapons and small arms fire. Moments after he had reached cover in a ditch, there was a devastating explosion nearby and he was painfully wounded. As one of his comrades crawled to his position to offer assistance, an enemy grenade was detected flying through the air toward Corporal Sosa's position. As the grenade landed and began rolling toward his comrade, Corporal Sosa rolled on top of the grenada to save the soldier from its blast and was mortally wounded by the exploding grenade. His courageous actions in complete disregard for his own safety were responsible for saving the life of his comrade. Corporal Sosa's extraordinary heroism was in keeping with the highest traditions of the military service and reflects great credit upon himself, his unit and the United States Army.

XI\_SOLDIER'S MEDAL. 1. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

First Sergeant Ronald S. Brooks, RA14530892, Battery C, 3d Missile Battalion, 79th Artillery, United States Army, distinguished himself by an act of heroism at approximately 0130 hours on 27 March 1968, near Butzbach, Germany, by voluntarily risking his life to singlehandedly disarm a mentally deranged soldier armed with a twelve-inch butcher knife. After a lengthy three and one-half hour search, in darkness and rough terrain, the individual was located and Sergeant Brooks chose to disarm him immediately rather than wait for assistance from the Military Police or Medical personnel. By immediately disarming the individual, Sergeant Brooks prevented possible death or injury

to the soldier or to one or more of the nineteen men who accompanied him in the search for this man. This valorous action performed by Sergeant *Brooks* represents heroism and devotion to duty in its truest form. His complete disregard for himself when faced with grave danger is evidence of his sincere dedication to his fellow man. His bravery and courage have set an outstanding example worthy of praise by both his superiors and subordinates. Sergeant *Brooks'* heroic action is in keeping with the highest traditions of the military service and reflects greatly upon himself and the United States Army.

2. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Major Paris D. Davis, OF110648, (then Captain), Armor, United States Army, distinguished himself by heroism not involving actual conflict with an armed enemy in the Republic of Vietnam on 13 May 1965 at Bong San. He witnessed an aviation fuel truck jackknife and roll over on its side, pinning the driver to the steering wheel. Disregarding his personal safety, he ordered the remaining members of his detachment to stay clear of the truck, and proceeded to pry the steering wheel away from the trapped driver. Disregarding the pleas to abandon the driver and flaming truck, Major Davis worked his comrade loose and then carried him away from the truck just as it exploded. Major Davis heroic actions were in keeping with the highest traditions of the military service and reflect great credit upon himself, his unit, and the United States Army.

Private James B. Kirk, RA53529598, United States Army, a member of Company F, Sixth Battalion, Student Brigade, United States Army Southeastern Signal School, Fort Gordon, Georgia, distinguished himself by heroism not involving conflict with an armed enemy. At 1000 hours, 2 June 1968, Private Kirk, with complete disregard to personal danger and at the voluntary risk of his own life, distinguished himself by heroically entering a burning aircraft to extract the injured occupants. A Piper Comanche, carrying a pilot and four passengers, plummeted off the end of the runway at Coulbourn Airport, Lancaster, South Carolina, crashed into a small building (the control tower) and burst into flames. As other bystanders fled the scene, fearful of an explosion from the burning gasoline, Private Kirk rushed to the aircraft and climbed upon the right wing to rescue the passengers. Two women, their clothes and hair on fire, were attempting to escape. Private Kirk assisted them from the aircraft, extinguished the flames and returned to the cabin door of the plane. The pilot was slumped over the controls in the left front seat, with gasoline gushing into the cabin from a ruptured fuel tank. Risking his life, Private Kirk hauled a passenger from the right front seat onto the wing and helped him to the ground. As Private Kirk turned again to the aircraft, the plane exploded and the cabin was engulfed in flames. The prompt, heroic action of Private Kirk, with utter disregard for his own personal safety, saved the lives of three persons. His heroism is truly worthy of emulation, reflects great credit upon himself and the United States Army, and is in keeping with the finest traditions of the military service.

4. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Sergeant Clifford J. Knappenberger, RA33772380, United States Army, distinguished himself by selflessly imperiling his own safety in saving a young girl from drowning. On 15 June 1945, Sergeant Knappenberger, while inspecting his guard, heard a call for help from a young girl who was swimming in a winter harbor 100 yards distant from his post. Without hesitation Sergeant Knappenberger started running toward the lagoon. He swam out toward the girl in distress. After going twenty-five yards, he noticed that she had gone under the water once and then came to the surface again. He increased his speed and reached her in time to prevent her sinking again. The girl struggled and grasped Sergeant Knappenberger around the neck. Sergeant Knappenberger remained calm and succeeded in bringing the girl safely to shore. He then gave her artifical respiration and revived her. Sergeant Knappenberger's heroic act reflects the utmost credit upon himself and the military service.

5. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Major Kenneth E. Lewis, O2205659, Quartermaster Corps, United States Army, distinguished himself by heroic action at the risk of his own personal safety on 25 June 1968 at Fort Bragg, North Carolina. While participating in a parachute training jump Major Lewis experienced a mid-air collision with a fellow jumper whose main parachute had failed to deploy. After having fallen through Major Lewis' suspension lines, the other jumper was tumbling through the air while the added weight of two jumpers suspended by one parachute resulted in a hazardously rapid rate of descent. Realizing that the other jumper was not in position to activate his reserve parachute, and despite the imminent danger to himself, Major Lewis immediately ceased his efforts to disentangle himself from the other man's suspension lines. Although he was rapidly approaching the ground and a natural reaction would be to prepare for his own landing, Major Lewis unhesitatingly wrapped the suspension lines around his arms and held onto the enlisted man's canopy, thereby arresting the tumbling action of the man and restoring his body to an upright position, enabling the other jumper to activate his reserve. Even after the deployment of the reserve parachute, Major Lewis, aware of the other jumper's close proximity to the ground, continued to hold onto the enlisted man's main canopy until his own impact with the ground. Major Lewis' unselfish actions with complete disregard for his own personal safety prevented the other jumper from suffering certain injury and possible death. His perseverance in directing his total efforts to the safety of the other jumper precluded Major Lewis from preparing for his own landing, and resulted in the fracture of his right hip. Major Lewis' perception, judgment and decisive action under extremely arduous and hazardous circumstances, and his voluntary risk of life with his only concern being for the welfare of a fellow soldier, are in the highest traditions of the service and reflects great credit upon himself, his organization and the United States Army.

6. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Private First Class Dennis N. Moro, ER28640710, United States Army, distinguished himself by heroism on 28 June 1968 at approximately 1530 hours while he was on duty in a battalion motor pool during a tactical exercise. At this time he saw a live CS grenade roll underneath a 4,500-gallon gasoline tanker. The intense heat from this grenade ignited a gasoline hose attached to the tanker truck. Private Moro observed what had happened, and, although he was not wearing a gas mask nor equipped with any protective clothing or equipment, he quickly obtained a fire extinguisher from a nearby vehicle and, at the risk of bodily injury and even death, entered the dense cloud of CS chemical smoke, extinguished the flame, and kicked the burning grenade from underneath the gasoline tanker. By his bold and audacious actions he prevented an explosion of the loaded tanker truck that would have engulfed other nearby vehicles. Approximately 20 men working in the motor pool area owe their safety to Private Moro's courageous action. Private Moro's willingness to risk his life, by his cool and courageous action, and with complete disregard for his own safety, undoubtedly prevented a terrible tragedy. His quick thinking and selfless concern for the safety of his comrades reflect great credit upon himself and the United States Army.

7. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Staff Sergeant Patrick J. O'Connor, RA11374024, United States Army, distinguished himself by heroism on 29 May 1968 at the handgrenade confidence course, Range 22, Fort Polk, Louisiana. As the principal instructor on the live grenade course, Sergeant O'Connor was responsible for supervising and assisting in the throwing of the live grenades. As the trainee brought the live grenade to the throwing bunker he was instructed as to how to pull the pin. While attempting to pull the pin, the trainee had difficulty and panicked. He succeeded in pulling the pin but in doing so, the grenade slipped from his grasp and started to fall. The trainee hit it into the air and proceeded to run back up the range. Sergeant O'Connor unhesitatingly jumped after the grenade, slapping it outside of the bunker. He then went after and tackled the trainee, covering him with his own body and shielding him from possible fragments. Sergeant O'Connor could have easily stepped to the side of the bunker and avoided possible danger; however, with disregard for his personal safety, he saved the trainee from being maimed or possibly killed. This reflects great credit upon himself, the Noncommissioned Officer Corps and the United States Army. (This award supersedes the Army Commendation Medal awarded to Staff Sergeant Patrick J. O'Connor for heroism on 29 May 1968 as announced in General Orders Number 177, Headquarters U.S. Army Training Center, Infantry and Fort Polk, Fort Polk, Louisiana 71459, dated 10 July 1968.)

8. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Staff Sergeant Ted L. Owens, RA24995587, United States Army, distinguished himself by heroism when, at great risk to his own life, he saved the life of a fishing accident victim in the treacherous waters of the Occoquan River, Woodbridge, Virginia. At approximately 1430 hours on the afternoon of 5 May 1968, Sergeant Owens was fishing when he heard cries for help. Running toward the cries and observing that the individuals who were at the immediate

scene were making no effort to save the drowning youth, Sergeant Owens, showing utter disregard for his own personal safety, plunged into the turbulent river and swam to where he last saw the victim. He was forced to dive under, fight the current, find the helpless youth, and then struggle back to the safety of the pier. This heroic act averted certain tragedy and reflects greatest credit upon himself and the United States Army.

9. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Specialist Four Thomas L. Stockett, RA11930013, United States Army, distinguished himself by heroic actions not involving actual conflict with the enemy. At 1130 hours, 2 May 1968, while on duty as Military Policeman, Specialist Stockett observed a four-story building almost totally encompassed by flame. Proceeding immediately to the vicinity of the fire, Specialist Stockett observed German nationals attempting to assist a German male who had suffered head injuries in falling from the building. While rendering first aid to the German male Specialist Stockett noticed other civilians pointing to the building in an excited manner. Recognizing their intentions in informing him that other individuals were trapped inside the building, Specialist Stockett immediately proceeded to the entrance. With complete disregard for his own life and safety, fully cognizant that the force of the fire implied complete destruction of the building, Specialist Stockett proceeded up the stairs until the heat and flames impeded his progress. Ascertaining the absence of individuals in his area, Specialist Stockett turned towards the entrance of the building. During his return he noticed a fallen female. Physically carrying the lady out of the building, Specialist Stockett again rendered first aid to injured personnel. Upon arrival of German firefighting equipment and personnel, Specialist Stockett returned to his Military Police sedan and returned to his prescribed duties. The actions by Specialist Stockett in this instance are in the highest traditions of the military service and reflect creditably upon himself, his unit and the United States Army.

10. By direction of the President, under the provisions of the Act of Congress approved 2 July 1926, a Soldier's Medal for heroism not involving actual conflict with an enemy is awarded to:

Specialist Four James D. Vaughn, RA17729627, United States Army, distinguished himself in a heroic manner by selflessly imperiling his own safety when he saved the life of his drowning swimming companion. At 1300 hours on the afternoon of 17 March 1968 Specialist Vaughn and his soldier companions were fishing along the Swat River in Turkey when they heard cries for help. Specialist Vaughn's fellow soldier, attempting to swim across the river, had developed leg cramps and was being carried downstream by the swift current. Realizing that he would be caught in the same undercurrent that was taking his fellow soldier to his impending fate, Specialist Vaughn entered the water. Hampered by the current and extremely cold water, Specialist Vaughn, fighting exhaustion, reached the now-unconscious victim. Specialist Vaughn somehow fought the elements with unsurpassed resolve and physical stamina, resulting in a miraculous saving of a human life. Solely because of his courage, quick reaction and total disregard for his safety did Specialist Vaughn avert certain tragedy. Specialist Vaughn's heroic act reflects utmost credit upon himself, the United States Army Security Agency and the

United States Army. (This award supersedes the Army Commendation Medal awarded to Specialist Four *Vaughn* for heroism on 17 March 1968, as announced in General Orders Number 91, Headquarters, U.S. Army Security Agency, Arlington Hall Station, Arlington, Virginia 22212, dated 17 September 1968.)

XII\_BRONZE STAR MEDAL. 1. By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal with "V" Device for heroic achievement in connection with military operations against hostile forces is awarded to:

Sergeant First Class Howard C. Breedlove, RA52403032, United States Army, distinguished himself by heroic action while serving as noncommissioned Officer-in-Charge of the Vietnam-based element of the United States Army Special Photographic Detachment, Pacific. Sergeant Breedlove personally supervised and participated in the pictorial coverage of the heavy fighting on the outskirts of Saigon on 6 May 1968. On that day Sergeant Breedlove voluntarily accompanied Republic of Vietnam Army forces as they advanced against a heavily armed and well-entrenched enemy force estimated at one North Vietnamese Army/Viet Cong battalion. As Republic of Vietnam Army elements approached enemy positions they came under intense small arms and heavy weapons fire. Advancing with the vanguard of Republic of Vietnam Army forces into a hail of enemy fire, Sergeant Breedlove began fearlessly to film the attack. Displaying complete disregard for his personal welfare, he repeatedly exposed himself to enemy fire in order to obtain the best possible pictorial coverage. While he was maneuvering for a better vantage point Sergeant Breedlove was struck down and wounded in the leg by enemy shrapnel. Though visibly shaken by the explosion and severely crippled by his wound, he refused medical evacuation and continued to film the battle until contact was broken. Throughout this vicious battle Sergeant Breedlove displayed aggressiveness, professionalism, and almost incredible courage in the face of the enemy. His outstanding display of devotion to duty and personal bravery is in keeping with the highest traditions of the military service and reflects great credit upon himself, his unit, and the United States Army.

2. By direction of the President, under the provisions of Executive Order 11046, 24 August 1962, a Bronze Star Medal with "V" device for heroism in connection with military operations against hostile forces is awarded to:

Sergeant First Class Frank D. Cummings, RA21979805 (then Specialist Six), United States Army, distinguished himself by heroism in connection with military operations against a hostile force on 14 March 1967 in the Republic of Vietnam. On this date, Company A, 1st Battalion, 22d Infantry, was conducting search-and-destroy operations west of Pleiku. Sergeant Cummings was attached to company headquarters when the Second Platoon in company formation was brought under intense enemy ground fire. Shortly thereafter all sides of Company A were engaged in heated battle with the numerically superior hostile force. Sergeant Cummings immediately began attending to a number of critically wounded in the Third Platoon. In an expeditious but professional manner he dressed the wounded and hastily proceeded to the area of the Second Platoon, whose members were bravely attempting to stem yet another vicious enemy thrust. In addition to providing medical care to the increasing numbers of wounded comrades, Sergeant Cummings provided heroic support to the Second Platoon by placing effective fire upon the enemy posi-

tions, destroying several of the enemy. During the entire action, lasting several hours, Sergeant Cummings exposed himself to withering enemy fire, and, although critically wounded in back, leg, and foot, he remained calm, continually attending to the wounded members of Company A; providing an inspirational example of the combat medic. Sergeant Cummings' unselfish display of courage, determination and concern for the welfare of his fellow soldiers is in keeping with the highest traditions of the military service and reflects great credit upon himself, his unit, and the United States Army.

3. By Direction of the President, under the provisions of Executive Order 9419, 4 February 1944, a Bronze Star Medal with "V" device for heroic achievement in connection with military operations against an enemy of the United States is awarded to:

Technician Fifth Grade Frank B. Ford, 37345331, United States Army, distinguished himself by heroic action while serving at Landroff, France on the night of 14-15 November 1944. When the forward observer tank which he was driving was forced to leave the road to get around a knocked-out halftrack it became stuck in a ditch. Realizing the importance of getting his tank into Landroff, Technician Ford sought assistance from another tank nearby. Disregarding German artillery rounds bursting in close proximity he exposed himself in order to guide the other tank into position in front of his own and to connect a tow cable between the two. Through skillful driving he then succeeded in getting his tank out of the ditch. During a later counterattack he left the safety of a stone building and exposed himself to heavy German fire in order to reach his tank and be ready to move it if necessary. At this time he was in fact wounded by small arms fire. The heroism exhibited by Technician Ford was instrumental in defeating a serious German counterattack. Had he not succeeded, at considerable personal risk to himself, in getting his tank out of the ditch and into Landroff, its radio would not have been available to transmit the call for artillery fire which thwarted the German attack. Without the artillery fire, Landroff would assuredly have been overrun with heavy loss of American lives and serious disruption in the advance to the Siegfried Line. His outstanding display of devotion to duty and personal bravery is in keeping with the highest traditions of the military service and reflects great credit upon himself and the United States Army.
