I_THE PRESIDENTIAL UNIT CITATION (ARMY). Award of the Presidential Unit Citation (Army) by the President of the United States of America to the following unit of the Armed Forces of the United States is confirmed in accordance with paragraph 194, AR 672-5-1. The text of the citation, signed by President Lyndon B. Johnson 28 December 1968 reads as follows:

By virtue of the authority vested in me as President of the United States and as Commander in Chief of the Armed Forces of the United States I have today awarded the Presidential Unit Citation (Army) for extraordinary heroism to:

TROOP A, 1ST SQUADRON, 9TH CAVALRY TROOP B, 1ST SQUADRON, 9TH CAVALRY TROOP C, 1ST SQUADRON, 9TH CAVALRY TROOP D, 1ST SQUADRON, 9TH CAVALRY

HEADQUARTERS AND HEADQUARTERS TROOP, 1ST SQUADRON, 9TH CAVALRY OF THE 1ST CAVALRY DIVISION (AIRMOBILE)

The foregoing assigned units of the 1st Squadron, 9th Cavalry, 1st Cavalry Division (Airmobile), United States Army, distinguished themselves by displaying extraordinary heroism in action against an armed hostile force in the Republic of Vietnam during the period 2 October 1966 through 24 October 1966. During the period cited, the Squadron was given the mission of conducting a reconnaissance in a vast, heavily defended area extending from the South China Sea west to the Kim Son River in the coastal plains region of central Vietnam. Elements of a North Vietnamese army division were believed to be located in this area. The Squadron conducted a series of classic cavalry operations, comparable with any recorded in United States military history, with devastating effects on all Viet Cong and North Vietnamese army units engaged. By the unparalleled application of exceptional imagination, fearless courage, and unrelenting determination, the Squadron succeeded in locating the emeny units within the vast area. The Squadron conducted air and ground reconnaissance with its 88 organic armed helicopters, highly mobile organic rifle platoons and other attached non-organic infantry elements. Scouting over the area, the Squadron aggressively engaged every enemy force encountered, regardless of its size. On 2 October 1966, a rifle platoon on a reconnaissance mission engaged an estimated enemy battalion-size force and annihilated approximately one-third of the numerically superior force in the first few hours of contact. The Squadron developed a major portion of all targets successfully destroyed by the Division throughout the period. The aggressiveness, determination, enthusiasm. and exemplary courage under fire demonstrated by all members of the 1st Squadron, 9th Cavalry, reflect great credit on the organization and stand in keeping with the highest traditions of the military service.

II_VALOROUS UNIT AWARD. By direction of the Secretary of the Army, under the provisions of paragraph 202.1, AR 672-5-1, the Valorous Unit Award is awarded the following-named units of the United States Army for extraordinary heroism while engaged in military operations during the periods indicated:

The citations read as follows:

1. TROOP A, 3D SQUADRON, 5TH CAVALRY.

TROOP A, 3D SQUADRON, 5TH CAVALRY distinguished itself by extraordinary heroism while engaged in military operations on 31 January 1968 in defense of the Bien Hoa Air Base in the Republic of Vietnam. Given the extremely hazardous mission of traveling along enemy infested Highway 1 to the besieged airfield, the cavalrymen were the object of three well-coordinated and effectively executed enemy ambushes along the route. The determined Viet Cong assailants directed deadly fires of antitank rockets, automatic weapons and small arms at the troopers from point blank range. With indomitable courage and relentless determination, the Black Knights repelled all attacks by saturating the area with devastating machinegun, grenade and rifle fire. When the men of TROOP A, 3D SQUADRON, 5TH CAVALRY reached their final objective, they moved out on a sweep of the area. A short time later, they clashed with two reinforced companies of Viet Cong and, although fighting against seemingly insurmountable odds, the troopers refused to leave their positions. killing the communist aggressors at extremely close range. Through their unswerving perseverance, exemplary bravery and tactical proficiency, the troop's members contributed immeasurably to the successful defense of the Bien Hoa Air Base. The men of TROOP A, 3D SQUADRON, 5TH CAVALRY displayed extraordinary heroism and devotion to duty which are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

2. THE 4TH BATTALION, 31ST INFANTRY, 196TH LIGHT INFANTRY BRIGADE, AMERICAL DIVISION.

The 4TH BATTALION, 31ST INFANTRY, 196TH LIGHT INFANTRY BRIGADE, AMERICAL DIVISION distinguished itself by extraordinary heroism while engaged in military operations during the period 15 November 1967 to 3 February 1968 in the Que Son and Hiep Duc Districts of the Republic of Vietnam. Initially participating in Operation WHEELER/WALLOWA in the Que Son District, the battalion's personnel demonstrated exemplary courage and relentless determination in conducting highly successful search, destroy and interdiction missions. On 22 November 1967, they were committed to an assault upon a large North Vietnamese Army force in the vicinity of the Dong Son hamlet. Because of the voluminous firepower and aggressiveness of the unit's members during three consecutive days of fierce fighting, the enemy was forced to break contact and the battle was held as an overwhelming victory for the fighting men of the 4TH BATTALION, 31ST INFANTRY, 196TH LIGHT INFANTRY BRIGADE, AMERICAL DIVISION. Subsequently operating in the Hiep Duc District, the battalion's mem-

bers served as the security force for Fire Support Base WEST. On the morning of 3 January 1968, a large communist force launched an intensive attack upon the base and pressed on for nine days and nights with violent mortar, rocket and rocket propelled grenade assaults in an attempt to break through the defense. Exhibiting unparalleled bravery and perseverance, the security elements repulsed every enemy attack while the maneuver elements simultaneously engaged and defeated regimental-sized units of the North Vietnamese Army in the Hiep Duc Valley. The men of the 4TH BATTALION, 31ST INFANTRY, 196TH LIGHT INFANTRY BRIGADE, AMERICAL DIVISION displayed extraordinary heroism and devotion to duty which are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

3. THE 2D BATTALION (MECHANIZED), 47TH INFANTRY and its attached unit: Company B, 4th Battalion, 39th Infantry.

The 2D BATTALION (MECHANIZED), 47TH INFANTRY and the attached unit distinguished themselves by extraordinary heroism while engaged in military operations on 31 January 1968 in defense of the II Field Force headquarters and the Long Binh-Bien Hoa military complex in the Republic of Vietnam. When the enemy launched a concerted ground and rocket attack against the complex, the battalion provided reinforcements for the II Field Force Vietnam headquarters, the Long Binh ammunition depot and the headquarters of the III Corps, Army of the Republic of Vietnam. Throughout the day, all elements of the unit fought valiantly to overcome strong enemy resistance in Widows Village, Ho Nai Village, Bien Hoa City and the ammunition storage areas. Headquarters and support troops of the 2D BATTALION (MECHANIZED), 47TH INFANTRY assisted the maneuver forces by establishing and maintaining command and control facilities despite being under constant enemy fire; maintenance recovery crews and resupply personnel worked tirelessly to evacuate disabled armored vehicles and furnish vital ammunition resupply directly to the battle area; medical personnel, exposed time and again to enemy fire, performed brilliantly, saving the lives of many members of the battalion by their actions. By nightfall on 31 January, the battalion had successfully accomplished all of the varied tasks assigned to it and had soundly defeated all enemy efforts to destroy installations that were vital to the free world mission in the Republic of Vietnam. At the termination of the action, the unit had rendered the communist forces combat-ineffective by inflicting over two hundred casualities, capturing thirty-two enemy combatants and confiscating eighty-four enemy weapons. The men of the 2D BAT-TALION (MECHANIZED), 47TH INFANTRY displayed extraordinary heroism and devotion to duty which are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

III_VALOROUS UNIT AWARD. By direction of the Secretary of the Army, under the provisions of paragraph 202.1, AR 672-5-1, the Valorous Unit Award is awarded the following-named unit of the United States Army and its attached United States Air Force and Army of the Republic of Vietnam units for extraordinary heroism while engaged in military operations during the period indicated:

DETACHMENT B-52 (PROJECT DELTA), 5TH SPECIAL FORCES GROUP (AIRBORNE), 1ST SPECIAL FORCES and its assigned and attached units distinguished themselves by extraordinary heroism while engaged in military operations during the period 4 March to 4 April 1968 in the Hue/ Phu Bai area of the Republic of Vietnam. When intelligence sources indicated a massive enemy buildup in the I Corps Tactical Zone, the Deputy Commander, United States Military Assistance Command Vietnam, tasked the unit with the hazardous mission of infiltrating the region, locating the suspected enemy supply route and interdicting the vital lines of communication. Exhibiting the characteristic professionalism that has enabled DETACHMENT B-52 (PROJECT DELTA), 5TH SPECIAL FORCES GROUP (AIRBORNE), 1ST SPECIAL FORCES to become the foremost reconnaissance unit in the theater, the Delta staff developed an extremely complex and highly effective plan of operations. The existence of the new major supply route was quickly confirmed and the members of the unit immediately undertook extensive interdiction activities. Expert utilization of tactical air support by the ground elements continuously dealt demoralizing blows to the numerically superior enemy forces. The relentless determination and exemplary perseverance of the members of this proud unit were key factors in averting a second major offensive against the Hue/Phu Bai area. The men of DETACHMENT B-52 (PROJECT DELTA), 5TH SPECIAL FORCES GROUP (AIRBORNE), 1ST SPE-CIAL FORCES displayed extraordinary heroism and devotion to duty which are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

IV__MERITORIOUS UNIT COMMENDATION. The citation reads as follows:

The foregoing units of the 1st Logistical Command distinguished themselves by exceptionally meritorious conduct in the performance of outstanding services in support of combat operations in the Republic of Vietnam from 1 January 1967 to 15 April 1968. During this period, the Command successfully supported more than 50 major tactical operations. To keep pace with these widely dispersed and highly mobile operations, the 1st Logistical Command expanded and refined the forward support area concept to a point where its performance was acclaimed outstanding by combat commanders. Throughout the Republic of Vietnam the Command repeatedly demonstrated its ability to respond rapidly and flexibly to support requirements even under the most adverse conditions. The Command was also responsible for the operation of seaports through which the majority of personnel, equipment and supplies arriving in Vietnam were processed. In addition to normal resupply activities which averaged 700,000 short-tons of incoming cargo each month, the Command disembarked numerous units and combat forces arriving in Vietnam for the first time, including the 9th Infantry Division, the Royal Thai Army Volunteer Regiment, the 198th Light Infantry Brigade, the 101st Airborne Division (—), and the 11th Light Infantry Brigade. Throughout the period, the personnel of the 1st Logistical Command met every challenge with a high degree of resourcefulness and dedication. They have made a vital contribution to the success of the United States and other free world forces' counterinsurgency efforts in the Republic of Vietnam. The 1st Logistical Command's professional competence and outstanding achievements were in the highest traditions of the military service and reflect great credit on itself and the United States Army.

V_MERITORIOUS UNIT COMMENDATION. By direction of the Secretary of the Army, under the provisions of paragraph 203, AR 672-5-1, the Meritorious Unit Commendation is awarded to the following named units of the United States Army for exceptionally meritorious achievement in the performance of outstanding service during the periods indicated:

The citations read as follows:

1. THE 84TH ENGINEER BATTALION (CONSTRUCTION) and its attached units:

73d Engineer Company (First Oak Leaf Cluster) (for the period 10 November 1966 to 31 October 1967)

513th Engineer Company (Dump Truck) (Second Oak Leaf Cluster for the 1st Platoon) (First Oak Leaf Cluster for the remainder of the company) (for the period 20 March 1967 through 31 October 1967)

The S4TH ENGINEER BATTALION (CONSTRUCTION) and its attached units distinguished themselves in support of military operations in the Republic of Vietnam during the period 1 June 1966 through 31 October 1967. Throughout the period of this award, the battalion accomplished an almost

unbelievable number of construction projects in support of the free world military assistance forces. Imbued with resolute determination and a wealth of professional abilities, the battalion successfully completed a number of important assignments including: construction of a pontoon pier and the first ramps in the Qui Nhon harbor, refrigerated warehouse facilities in Qui Nhon and Phu Tai, storm sewers in Qui Nhon, access roads for the port of Qui Nhon, an automatic data processing facility and a large evacuation hospital. In addition to this, the 84TH ENGINEER BATTALION (CONSTRUCTION) manned an important security outpost which overlooks several strategic military targets in the Qui Nhon area. On several separate occasions, members of the unit displayed unique gallantry not often viewed in this type of a unit. To meet the challenge imposed by stringent deadline dates, the personnel of the battalion often worked twenty-four hours a day over extended periods of time. Throughout the construction season and into the monsoons, they overcame the severe tropical climate, unvielding terrain and hostile insurgents to complete every assigned project in a superb manner. The remarkable proficiency and devotion to duty displayed by the members of the 84TH ENGINEER BAT-TALION (CONSTRUCTION) are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

2. THE 84TH ENGINEER BATTALION (CONSTRUCTION) and attached unit:

1st Platoon, 513th Engineer Company (Dump Truck)

The 84TH ENGINEER BATTALION (CONSTRUCTION) and attached unit distinguished themselves in support of military operations in the Republic of Vietnam during the period June 1965 to May 1966. The members of these units demonstrated extraordinary diligence, tenacity and professional competence while providing superb engineering support to free world military forces. Commencing construction of an engineer base camp immediately upon arrival at Qui Nhon, the battalion aggressively assumed its prodigious mission with resolute determination. Even before this project was completed, the unit had also begun support work on two crusher sites, several depots, a Special Forces camp and rehabilitation of the An Khe Airfield. Within the first few months, the battalion was augmented by the 1st Platoon, 513th Engineer Company (Dump Truck) and, despite the tremendous work load, all projects were completed with minimum delay. Working against severe terrain, oppressive climate and the hostile environment, the personnel of the 84TH ENGI-NEER BATTALION (CONSTRUCTION) and the attached unit never faltered from their relentless efforts to complete every assigned task. Through their singular proficiency, numerous projects of vital importance to the counterinsurgency effort were rapidly and resourcefully constructed, including a hospital, helipads, pontoon piers, fuel systems, signal exchanges and relay stations, roads and billeting facilities. The exemplary workmanship, perseverance and dedicated devotion to duty displayed by the members of the 84TH ENGI-NEER BATTALION (CONSTRUCTION) and the attached unit were in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

3. THE 577TH ENGINEER BATTALION (CONSTRUCTION) and attached unit:

513th Engineer Company (Dump Truck) (for period 2 August 1966–19 March 1967)

The 577TH ENGINEER BATTALION (CONSTRUCTION) and the attached unit distinguished themselves in support of military operations in the Republic of Vietnam during the period 2 August 1966 to 11 June 1967. Shortly after arriving in-country, the unit became engaged in a heavy construction program in support of operations against the insurgents. Attacking each project with the sense of urgency required in counterinsurgency operations, it constructed a 400-bed hospital in Nha Trang which was utilized by Republic of Korea forces. Moving to Cam Ranh Bay, Company D instituted a massive construction project for the 22d Replacement Battalion, including the erection of six two-story billets, a fifteen-hundred-man messhall, showers, latrines and administrative facilities. Later, the entire 577TH ENGINEER BATTALION (CONSTRUCTION) made a one-hundred-mile tactical motor march over a recently opened highway to Tuy Hoa, where work commenced on a CH-47 Chinook helicopter facility and a port complex at nearby Vung Ro Bay. The successful completion of the DeLong pier opened this area of Vietnam to direct cargo shipments from ocean-going vessels and subsequently markedly improved logistical procedures throughout the adjacent area. The rapid manner in which the unit responded to each assignment is indicative of the excellent caliber of its overall performance. The remarkable proficiency and devotion to duty displayed by the members of the 577TH ENGINEER BATTALION (CON-STRUCTION) are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

4. THE 33D ORDNANCE COMPANY (AMMUNITION) (DIRECT SUPPORT/GENERAL SUPPORT).

The 33D ORDNANCE COMPANY (AMMUNITION) (DIRECT SUPPORT/GENERAL SUPPORT) distinguished itself in support of military operations in the Republic of Vietnam during the period 1 August 1967 to 15 February 1968. Demonstrating professionalism and determination, the company's members rendered outstanding Class V support to approximately 350 United States military units throughout the theater. Further, they furnished ammunition support to elements of the armies of the Republic of Vietnam and the Republic of Korea. Significant among their many accomplishments was their tireless effort throughout the joint North Vietnamese Army/Viet Cong TET Offensive. During this critical period, the men of the 33D ORDNANCE COMPANY (AMMUNITION) (DIRECT SUPPORT/GENERAL SUP-PORT) handled numerous emergency shipments in addition to their regular workload and, although operating at only sixty-five percent of their normal strength, they met the added commitments in a timely and efficient manner. Constantly striving to increase the effectiveness of the existing operation, the unit's personnel effected significant improvements in both the ammunition storage pads and the perimeter of the Ammunition Storage Area (Yankee), thereby enhancing the efficiency and security of the area. Through their singular initiative, adaptability to all contingencies and total dedication to providing the best possible ammunition support, they contributed immeasurably to the free world military assistance effort in the Republic of Vietnam. The remarkable proficiency and devotion to duty displayed by the members of the 33D ORDNANCE COMPANY (AMMUNITION) (DIRECT SUPPORT/

GENERAL SUPPORT) are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

5. THE 2D BATTALION, 40TH ARTILLERY, 199TH INFANTRY BRIGADE (SEPARATE) (LIGHT).

The 2D BATTALION, 40TH ARTILLERY, 199TH INFANTRY BRIGADE (SEPARATE) (LIGHT) distinguished itself in support of military operations in the Republic of Vietnam during the period 1 January 1967 to 15 February 1968. Throughout this critical time, the battalion's highly responsive and extremely accurate fire support was a major contributing factor in the achievement of superiority over the enemy forces. Initiating a revolutionary system of nonstandard configuration, the unit's personnel established an outstanding record of artillery effectiveness and achieved one of the lowest artillery incident rates of any unit in the theater. Because of their peerless accuracy, supporting fire was enjoyed by friendly elements in the most densely populated areas without unnecessary damage to civilian facilities. The men of the 2D BATTALION, 40TH ARTILLERY, 199TH INFANTRY BRIGADE (SEPARATE) (LIGHT) fired day and night during the enemy's TET offensive in support of both United States and Army of the Republic of Vietnam units that were in heavy, close contact with the hostile forces. They worked around the clock with a minimum of rest and accounted for extensive communist losses, thwarting the enemy's efforts to inflict heavy casualties upon the allied forces. Despite the adverse weather and terrain, the men maintained an exceptionally high standard of equipment readiness and esprit de corps. Through their determination, initiative and expertise, they materially advanced the free world struggle against communist aggression in the Republic of Vietnam. The remarkable proficiency and devotion to duty displayed by the men of the 2D BATTALION, 40TH ARTILLERY, 199TH INFANTRY BRI-GADE (SEPARATE) (LIGHT) are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

6. THE 148TH ORDNANCE COMPANY (AMMUNITION).

The 148TH ORDNANCE COMPANY (AMMUNITION) distinguished itself in support of military operations in the Republic of Vietnam during the period 1 April 1967 to 30 April 1968. Demonstrating professional competence and determination, the company's members accomplished their vital mission of providing ammunition support to the entire IV Corps Tactical Zone, part of the III Corps Tactical Zone and the Vung Tau Special Zone in a truly outstanding manner. They effectively handled more than 240,000 short-tons of ammunition, overcoming numerous difficulties in order to insure that there was never a serious ammunition shortage in their area of responsibility. While operating the ammunition supply point at Dong Tam, members of the 148TH ORDNANCE COMPANY (AMMUNITION) were continually exposed to enemy rocket and mortar attack, but suffered no reduction in efficiency or mission output. Their singular performance during the enemy's TET offensive reflected accurately upon their technical proficiency and perseverance. During the weeks following TET, the men handled more than twenty-seven thousand tons of ammunition, responding flawlessly to four emergency resupply demands, one tactical emergency and thirty-one combat essential resupply demands. Because of their willingness to work long and arduous hours, no requests went unfilled. Through their initiative, resourcefulness and dedication, the company's men contributed immeasurably to the United States effort in the Republic of Vietnam. The remarkable proficiency and devotion to duty displayed by the members of the 148TH ORDNANCE COMPANY (AMMUNITION) are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.
