I\_\_VALOROUS UNIT AWARD. By direction of the Secretary of the Army, under the provisions of paragraph 202.1, AR 672-5-1, the Valorous Unit Award is awarded the following named units of the United States Army for extraordinary heroism while engaged in military operations during the periods indicated:

1. THE 3D SQUADRON, 5TH CAVALRY, 9TH INFANTRY DIVISION and its assigned and attached units:

The 3D SQUADRON, 5TH CAVALRY, 9TH INFANTRY DIVISION and its assigned and attached units distinguished themselves by extraordinary heroism while engaged in military operations on 27 and 28 June 1968 in Quang Tri Province in the Republic of Vietnam. Given the extremely hazardous and difficult mission of seeking out and engaging elements of the 812th North Vietnamese Army Regiment, the squadron made contact with a hostile force in the coastal village of Binh An. Two troops reacted immediately, forming a cordon around the trapped enemy. The men of the 3D SQUADRON, 5TH CAVALRY, launched two valiant assaults against the contained communist forces, but the cornered foe fought stubbornly and darkness prevented a rout of the entrenched enemy. When daybreak came, Troops A and B feinted forward, enabling the men of Troop B to sweep into the village. Although the suicidal defenders put up a bitter battle, the squadron's courageous troopers fought tenaciously as a team and cleared the area of the enemy. The heroic efforts of the cavalrymen killed 233 and captured 44 of the 300-man enemy force. The men of the 3D SQUADRON, 5TH CAVALRY displayed extraordinary heroism and devotion to duty which are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

2. BATTERY B, 1ST BATTALION, 21ST ARTILLERY, 1ST CAVALRY DIVISION (AIRMOBILE)

BATTERY B, 1ST BATTALION, 21ST ARTILLERY, 1ST CAV-ALRY DIVISION (AIRMOBILE) distinguished itself by extraordinary heroism while engaged in military operations in the Republic of Vietnam on 30 January 1968. During an enemy assault on Landing Zone "Leslie," the men of the artillery battery exhibited profound discipline under fire, exemplary courage and a determination to defend their position regardless of personal risk in repelling a vicious Communist offensive. American positions were initially battered by a continuous barrage of hostile mortar, recoiless rifle, antitank. and small arms fire which enabled the aggressors to penetrate primary defense positions and threaten the annihilation of the entire contingent. Due entirely to an alert and unanimous response, BATTERY B proved instrumental in halting the onslaught through effective close combat artillery shelling. Those not manning the howitzers were courageously resupplying a vital self-illumination gun or pursuing enemy soldiers moving between the primary defense line and the unit's perimeter. During this six-hour engagement, no one sought shelter despite the tremendous dangers inherent in a vicious firefight of this magnitude. Through their outstanding composure under trying circumstances, brilliant technical skill and exceptional display of gallantry, the men of the battery contributed materially to the free world struggle against Communist aggression in the Republic of Vietnam. The men of BATTERY B displayed extraordinary heroism and devotion to duty in keeping with the highest traditions of the military service and reflected distinct credit upon themselves and the Armed Forces of the United States.

## 3. THE 585TH ENGINEER COMPANY (DUMP TRUCK)

The 585TH ENGINEER COMPANY (DUMP TRUCK) distinguished itself by extraordinary heroism while engaged in military operations during the period 6 March 1968 to 14 March 1968 in the Republic of Vietnam. While supporting the 937th Engineer Group (Combat) in road improvement projects in the Pleiku/Kontum area, the company was ambushed on 6 March 1968 by a company-size enemy force. The Communist aggressors savagely attacked the American convoy with heavy rocket and mortar fire, but, through an immediate deployment of elements and courageous initiation of combat skill, the hostile force was held off until relief arrived. Despite intense sniper fire, the road was cleared and evacuation accomplished in an exemplary manner. Under similar circumstances on 13 March, another convoy was hit by ambushers. This time the enemy split the vehicle formation and overran its forward section, killing all officers. Only quick and heroic fighting by the 585TH ENGINEER COM-PANY prevented the entire convoy from extermination. Initially the attack was so fierce that evacuation helicopters could not land near the zone for nearly an hour. The battalion-size ambush was the largest of the war to that date and the ensuing firefight left forty-eight enemy dead. Again a relief convoy was formed and seven hours later the courageous defenders were evacuated. Through their personal display of gallantry, devotion to duty and remarkable perseverance, the unit contributed immeasurably to the free world support effort in the Republic of Vietnam. The men of the 585TH ENGINEER COMPANY displayed extraordinary heroism and devotion to duty in keeping with the highest traditions of the military service and reflected distinct credit upon themselves and the Armed Forces of the United States.

The DIVISION SUPPORT COMMAND, 1ST CAVALRY DIVISION (AIRMOBILE) and its assigned units distinguished themselves in support of military operations in the Republic of Vietnam during the period 1 June 1967 to 31 May 1968. The members of the command demonstrated an alert responsiveness and seemingly limitless capacity for work while providing unprecedented support to units i scated from Phan Thiet to Khe Sanh, Because of their determination while participating in Operations PERSHING, BOLLING, BYRD, MAC ARTHUR, WALLOWA, GREELY, PERSHING II, JEB STUART I and II, PEGASUS, DELAWARE AND JEB STUART III all logistical and support requirements were met in an exemplary manner. With the onset of the enemy TET Offensive, resupply became difficult and required vast amounts of planning and coordination with more complicated methods of maintaining stockage within besieged base camps. Airdrops were made into Camp Evans and the members of the DIVISION SUPPORT COMMAND recovered the supplies and rushed them to units in combat. The heroic actions of the men during this critical period in maintaining the logistical lifeline in the face of constant enemy attacks gained them the respect and admiration of all with whom they served. Through their unrelenting perseverance, consummate knowledge, and devotion to mission accomplishment, they contributed immeasurably to the free world effort in the Republic of Vietnam. The remarkable proficiency and devotion to duty displayed by the members of the DIVISION SUPPORT COMMAND and its assigned units are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

#### 2. THE 1ST ENGINEER BATTALION, 1ST INFANTRY DIVISION

The 1ST ENGINEER BATTALION, 1ST INFANTRY DIVISION distinguished itself in support of military operations in the Republic of Vietnam during the period 16 May 1967 to 2 June 1968. Exhibiting brilliant technical skill and remarkable determination, the battalion proved instrumental in rendering continuous engineer support to the 1st Infantry Division and its attached units. With personnel and equipment deployed throughout its 5,000-square-mile area of responsibility, the unit demonstrated a unique ability to respond promptly to urgent mission requirements. The organization excelled in an extensive spectrum of missions and greatly contributed to the war effort through its initiation of essential construction projects associated with numer-

ous strategic routes in the divisional area. One of the battalion's most important tasks was close combat assistance to infantry units and, through excellent service under the most trying conditions, the 1ST ENGINEER BATTALION accomplished its assignment in an exemplary manner. The unit's profound dedication, unequalled professional ability and remarkable motivation contributed significantly to the free world struggle against Communist aggression in the Republic of Vietnam. The remarkable proficiency and devotion to duty displayed by the members of the 1ST ENGINEER BATTALION are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

The 3D FIELD HOSPITAL and its attached units distinguished themselves in support of military operations in the Republic of Vietnam during the period 1 July 1967 through 30 June 1968. During this period the hospital admitted 8,749 patients with a total number of patient-care days exceeding 70,300. The esprit de corps of the units was evidenced in their willingness to work long and arduous hours to provide optimal medical care and treatment. The skill and determination of all personnel were particularly manifested during a time when over 1,029 direct battle casualties were treated during a three-month period. As the hospital evolved toward a station type, the 3D FIELD HOSPITAL remained high in morale, and the quality of the treatment performed never diminished. The personnel expended a maximum of effort to ensure high standards of medical care. Numerous projects were implemented, including improved powerplants, air conditioning of specialized wards, and isolation cubicles, to improve the working conditions and patient accommodations. Despite the flooding brought on by the monsoon season, the morale of the units remained high with efforts to eliminate possible recurrence. Through their singular initiative, adaptability to all contingencies and total dedication to mission accomplishment the unit's personnel have contributed immeasurably to the free world struggle against Communist aggression in the Republic of Vietnam. The remarkable proficiency and devotion to duty displayed by the members of the 3D FIELD HOS-PITAL are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

The 61ST MEDICAL BATTALION and its assigned and attached units distinguished themselves in support of military operations in the Republic of Vietnam during the period 8 June 1966 to 7 June 1968. The officers and men of the battalion displayed consummate knowledge, and a seemingly limitless capacity for work in providing medical support to free world forces throughout the 16,000 square miles of the II Corps Tactical Zone. The medical support provided Operations ADAMS, GERONIMO, FARRAGUT, SUMMERALL, OREGON and ROSE, through the implementation of forward clearing platoons was praised by the commanding general for its efficiency and expedient manner of handling and treating casualties. Realizing the importance of civic action to the pacification program in the theater, the men of the 61ST MEDI-CAL BATTALION voluntarily organized a medical civic action program and, through the use of modern medicine, much of the populace received treatment superior to any type previously available. The responsiveness of the battalion has played a significant role in preventing numerous outbreaks of the plague through inoculation, and their efforts in personal hygiene have aided in reducing reoccurrences of communicable diseases. To improve the security of one of the more vulnerable hospitals, the members of the battalion organized a selfhelp group and successfully built complete hospital facilities within conex's underground which were capable of efficiently handling up to eighty patients at once. Through their unrelenting perseverance and infectious enthusiasm, they contributed immeasurably to the free world struggle against Communist ag-

gression in the Republic of Vietnam. The remarkable proficiency and devotion to duty displayed by the members of the 61ST MEDICAL BATTALION and its assigned and attached units are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

The 313TH RADIO RESEARCH BATTALION and its assigned units distinguished themselves in support of military operations in the Republic of Vietnam during the period 1 June 1967 to 30 June 1968. Throughout this period, the battalion displayed remarkable proficiency and determined resourcefulness in providing excellent communications intelligence, communications security and electronic countermeasures support to I Field Force Vietnam. Through their unrelenting perseverance, seemingly limitless capacity for work and devetion to mission accomplishment, the units contributed immeasurably to the mission of I Field Force Vietnam in its struggle against Communist aggression in the Republic of Vietnam. The remarkable proficiency and devotion to duty displayed by the members of the 313TH RADIO RESEARCH BATTALION are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.

## 12. THE 329TH TRANSPORTATION COMPANY (HEAVY BOAT)

The 329TH TRANSPORTATION COMPANY (HEAVY BOAT) distinguished itself in support of military operations in the Republic of Vietnam during the period 1 January 1968 to 31 July 1968. Demonstrating exceptional competence and a thorough knowledge of logistics, the company significantly contributed to the fulfillment of support activities associated with military operations in the I Corps Tactical Zone. After performing superbly with the Vung Tau Sub-Area Command, the heavy boat organization accepted an extremely challenging task of supply maintenance in the Da Nang area. The 329TH TRANSPORTATION COMPANY, through employment of brilliant technical skill and profound determination, exhibited singular initiative in transporting combat-essential goods from Da Nang to the northern cities of Hue and Dong Ha. These resupply elements faced constant dangers and on numerous occasions the group's vessels were subjected to treacherous enemy attacks which inflicted injury and damage to men and material. Despite these hindrances, the unit continued to function as a well-organized team and proceeded in the establishing of exceptional records in low maintenance hours and high tonnage at the port of Da Nang. Through outstanding perserverance, profound dedication and extraordinary stamina, the men contributed immeasurably to the United States' logistical effort in the theater. The remarkable proficiency and devotion to duty displayed by the members of the 329TH TRANSPORTA-TION COMPANY (HEAVY BOAT) are in keeping with the highest traditions of the military service and reflect distinct credit upon themselves and the Armed Forces of the United States.
