**I. GENERAL COURTS-MARTIAL.** The Commanding Officer, United States Army Materiel Command, Europe, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial, *effective 1 September 1969*.

**II. GENERAL COURTS-MARTIAL.** The Commanding General, United States Army Training Center, Engineer and Fort Leonard Wood, Fort Leonard Wood, Missouri, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial, *effective 31 December 1968*.

**III. UNITED STATES ARMY COLD REGIONS RESEARCH AND ENGINEERING LABORATORY, NEW HAMPSHIRE.** *Effective 1 July 1969*, the United States Army Cold Regions Research and Engineering Laboratory, a class II activity under the jurisdiction of the Commanding General, U.S. Army Materiel Command, and its assigned functions (less those of the Photographic Interpretation Research Division), appropriate personnel, property and equipment is transferred to the jurisdiction of the Chief of Engineers. The Photographic Interpretation Research Division will remain under the jurisdiction of the Commanding General, U.S. Army Materiel Command.

**IV. ROTC UNIT AT NORFOLK STATE COLLEGE, NORFOLK, VIRGINIA.** *Effective 1 July 1969*, the ROTC unit at Norfolk State College (formerly Virginia State College Norfolk Division) is changed from a satellite to an independent unit.

**V. NATIONAL BOARD FOR THE PROMOTION OF RIFLE PRACTICE.** General Orders 15, 1969, is amended as follows:  
*Effective 6 July 1969*, Lieutenant Colonel Frank T. Lohmann, GS, USA, is appointed Executive Officer of the National Board for the Promotion of Rifle Practice vice Lieutenant Colonel Sidney R. Hinds, Jr., GS, USA.
