- I_SURVEILLANCE, TARGET ACQUISITION AND NIGHT OBSER-VATION (STANO) SYSTEMS OFFICE. Effective 1 July 1969, the Surveillance, Target Acquisition and Night Observation (STANO) Systems Office is established within the Office of the Chief of Staff, U.S. Army, to assist the STANO Systems Manager in the exercise of his responsibilities.
- II_SURVEILLANCE, TARGET ACQUISITION AND NIGHT OBSER-VATION (STANO) SYSTEMS MANAGER. 1. Effective 1 July 1969, the position of STANO Systems Manager is established within the Office Chief of Staff, U.S. Army, as the principal assistant and Staff adviser to the Chief of Staff for all matters pertaining to STANO programs.
- 2. The mission of the STANO Systems Manager, on a management-by-objective basis, is to insure that all Army battlefield surveillance and reconnaissance activities are coordinated.
- 3. The STANO Systems Manager will—
- a. Develop and maintain a coordinated STANO Master Plan (STAN MAP). The STANMAP will establish definitive objectives and goals, specify clear priorities for actions and resources (manpower, material, facilities, and funds), and delineate responsibilities of activities involved in STANO matters to insure integration of effort.
- b. Task the Army Staff for the preparation and coordination of STANO-related programs and other directives and actions pertaining to budgeting and funding, personnel support, facilities utilization, doctrine and materiel development, integrated test and evaluation, organization, training, procurement, production, logistic support, and deployment of STANO Systems.
- c. Except for the STANMAP, pass primary actions on STANO-related matters to Army Staff agencies for discharge of their normal responsibilities and functions in accordance with the STANMAP.
- d. To insure that STANO objectives are attained, monitor the Army Staff, major Army commands, and non-Army activities in STANO matters and intercede in STANO actions with informal coordination assistance or, as required, tasking authority over the Army Staff when objectives, policies, procedures, or performance by activity are deemed inadequate.
- e. Serve as the Army Staff point of contact for interservice, Office, Secretary of the Army, and Office, Secretary of Defense STANO matters.
- f. Supervise the assumption of Defense Communications Planning Group (DCPG) responsibilities by the Army; and serve as the Army point of contact for DCPG matters.
- 4. The positions of STANO Systems Manager and Deputy STANO Systems Manager are designated command positions.

III_JUNIOR ROTC UNITS AT MILITARY SCHOOLS. Junior ROTC units at the following essentially military schools (secondary school section of military junior colleges) are designated as honor ROTC units for the school year 1968-69. This rating is effective only for academic year 1969-70.
