I. GENERAL COURTS-MARTIAL. The Commanding General, United States Army Training Center, Infantry and Fort Jackson, Fort Jackson, South Carolina 29207, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial effective 10 March 1969.

II. GENERAL COURTS-MARTIAL. The Commanding Officer, United States Army School/Training Center, Fort McClellan, Alabama, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial effective 1 September 1969.

III. GENERAL COURTS-MARTIAL. The Commanding Officer, Fort Huachuca Support Command, United States Army, Fort Huachuca, Arizona 85613, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a) (6), to convene general courts-martial effective 15 August 1969.

IV. JUNIOR ROTC UNITS. 1. Effective 1 August 1969, class HS Junior ROTC units were established at the following institutions under the provisions of AR 145-10 with training to commence as indicated:

3. Effective 30 June 1970, class HS Junior ROTC unit is established at New Campus High School, Joliet, Illinois under the provisions of AR 145-10 with training to commence September 1970.

4. Effective 30 June 1971, class HS Junior ROTC unit is established at Osborne Road High School, Phoenix, Arizona, under the provisions of AR 145-10 with training to commence September 1971.
