- I. DIRECTORATE FOR CIVIL DISTURBANCE PLANNING AND OP-ERATIONS. Effective 1 September 1970, the Directorate for Civil Disturbance Planning and Operations, a class II activity within the Office, Chief of Staff, United States Army, is redesignated Directorate of Military Support.
- II_FORT IRWIN, CALIFORNIA. Effective 31 December 1970, Fort Irwin Calif., a class I installation under the jurisdiction of the Commanding General, Sixth United States Army, is placed in an inactive status.
- III_ST. LOUIS ARMY AMMUNITION PLANT, MISSOURI. Effective 30 September 1970, the St. Louis Army Ammunition Plant, Mo., a class II installation under the jurisdiction of the Commanding General, United States Army Materiel Command, is placed in an inactive status.
- IV. SENIOR ROTC UNITS. 1. Effective 30 June 1971, the SENIOR ROTC units at Yale University, New Haven, Conn., and New York University, Bronx, N.Y., will be terminated.
