IV_VIETNAMESE CROSS OF GALLANTRY WITH PALM. 1. The award of the Vietnamese Cross of Gallantry with Palm by the Republic of Vietnam to units of the United States Army listed below is confirmed.

2. The Cross of Gallantry with Palm has been awarded by the Government of the Republic of Vietnam for outstanding service during the period 23 September 1969 through 15 February 1970 to:

1ST BRIGADE, 1ST INFANTRY DIVISION and its assigned and attached units:

1st Battalion, 2d Infantry

1st Battalion, 28th Infantry

2d Battalion, 28th Infantry

1st Battalion, 5th Artillery

The citation reads as follows:

Operating in Vietnam from July 1965 to 26 June 70, the 1st Brigade, 1st United States Infantry Division, has proved to be an outstanding unit with abundant combat ability and has displayed a great spirit of self-sacrifice. In particular, during the period from 23 September 1969 to 15 February 1970, the men of the 1st Brigade, 1st United States Infantry Division, under the command of Colonel Paul F. Braim, have always overcome all difficulties, in fighting gallantly and continually achieving splendid victories, inflicting heavy personnel casualties and weapons losses upon the enemy. The accomplishments of the 1st United States Infantry Brigade have contributed substantially to the fight against Communist aggression in the Republic of Vietnam.

3. The Cross of Gallantry with Palm has been awarded by the Government of the Republic of Vietnam for outstanding service during the period 5 June 1969 through 6 September 1969 to:

2D BATTALION, 2D INFANTRY (1ST INFANTRY DIVISION)
The citation reads as follows:

Operating in Vietnam from July 1965 to 26 June 1970, the 2d Battalion, 2d United States Infantry, 1st Infantry Division, has proved to be an outstanding unit with abundant combat ability and rare self-sacrifice, which has repeatedly created great consternation among the enemy all over the III Corps Tactical Zone. In particular, during two military operations conducted from 5 June to 9 June and from 12 August to 6 September 1969 in the AN LOC and National Highway 13 Areas, the men of the 2d Battalion, 2d Infantry, under the command of Lieutenant Colonel Lee D. Brown, overcoming all difficulties in the face of dangerous terrain as well as intense enemy fire, fought gallantly, forcing the enemy to withdraw and inflicting heavy personnel casualties and weapons losses upon them. During the period when it assumed responsibility for security and control of vehicle convoys on National Highway 13, the Battalion coordinated with the Republic of Vietnam Armed Forces to destroy the enemy's secondary forces and underground infrastructures, thus eliminating the enemy's influence upon the convoys. With the above accomplishments, the 2d Battalion, 2d United States Infantry, 1st Infantry Division, has contributed substantially to the fight against the Communist aggressors in the Republic of Vietnam.

4. The Cross of Gallantry with Palm has been awarded by the Government of the Republic of Vietnam for outstanding service during the period April 1969 through October 1969 to:

1ST BATTALION, 16TH INFANTRY (1ST INFANTRY DIVISION)
The citation reads as follows:

A gallant and combat-seasoned United States Unit which displays an exemplary spirit of discipline. Operating in the Republic of Vietnam from July

1965 to 26 June 1970, the 1st Battalion, 16th United States Infantry, 1st Infantry Division, has always maintained the unyielding tradition of the United States Armed Forces, and has taken the initiative in all engagements with the Communists. It has thus contributed significantly to the splendid victories of Vietnamese-American Forces, inflicting severe defeats upon the Communist aggressors all over the III Corps Tactical Zone. In particular, during the period from April 1969 to October 1969, the 1st Battalion, 16th United States Infantry, under the command of Lieutenant Colonel David C. Martin, clashed fiercely with a North Vietnamese Communist Regular regiment and several Communist battalions at the AN LOC Rubber Plantation and along the lines of communication from the Saigon suburbs to the BE River. With their perfectly adapted combat methods, close liaison with their comrades-in-arms, coordinated fire distribution, and in spite of the fact that the battlefield was chosen by the enemy, the men of the 1st Battalion, 16th United States Infantry, easily took the initiative, crushing the enemy main force. After these victories, the 1st Battalion, 16th United States Infantry, continued to maintain the pressure to allow the asphalting of the Saigon-BE River road to be successfully completed. The outstanding victories against the Communists have brought about important results in the military and political fields, paralyzing Communist military potential, regularizing traffic, improving the economy of the BE River area and contributing to the struggle of the Republic of Vietnam Government to win the hearts of the people.

5. The Cross of Gallantry with Palm has been awarded by the Government of the Republic of Vietnam for outstanding service during the period 15 September 1969 through February 1970 to:

IST BATTALION, 18TH INFANTRY (1ST INFANTRY DIVISION) the citation reads as follows:

The 1st Battalion, 18th United States Infantry, 1st Infantry Division is one of the most outstanding units among Allied combat forces in Vietnam, Under the command of Lieutenant Colonel Thomas R. Finley, the men of the 1st Battalion, 18th United States Infantry, have outstandingly overcome such difficulties as jungles and swamps in areas of BIEN HOA and BIN DUONG Provinces and have achieved numerous splendid victories, creating panic and fear among North Vietnamese Communist Regular forces and support elements in their area of responsibility. In particular, during Operation 'TOAN THANG' (Phases III and IV) conducted in the III Corps Tactical Zone, the men of the 1st Battalion, 18th United States Infantry, outstandingly and gallantly utilized modern operational methods to destroy the enemy. This operation was a combined one with the 1st Battalion, 7th United States Field Artillery, 1st Infantry Division, and was the largest independent pacification operation undertaken by the 1st United States Infantry Division. During an 8-day siege, artillery fire was used to weaken the enemy's spirit. On 22 September 1969, United States troops, after maintaining their positions and crushing enemy raids seeking to neutralize the envelopment, assaulted its objectives, killing many Communists and seizing individual weapons, crew-served weapons, and a large quantity of stored rice. During this battle, the 1st Battalion, 7th United States Artillery, provided accurate artillery fire against its objectives, effectively aiding the 1st Battalion, 18th United States Infantry, to defeat the Communists while the operational force suffered insignificant losses.

Then, during the fourth phase of Operation 'TOAN THANG' conducted from 1 November 1969 to February 1970, the 1st Battalion, 18th United States Infantry, 1st Infantry Division, conducted more than 400 heliborne assaults, inficting heavy losses upon the K1 and K2 Battalions, DONG NAI Regiment, and 5th Communist Sub-region forces. With these accomplishments, the 1st Battalion, 18th United States Infantry, has materially contributed to the fight against Communist aggression in the Republic of Vietnam.

6. The Cross of Gallantry with Palm has been awarded by the Government of the Republic of Vietnam for outstanding service during the period 15 September

1969 through February 1970 to:

1ST BATTALION, 7TH ARTILLERY (1ST INFANTRY DIVISION)
The citation reads as follows:

The 1st Battalion, 7th United States Artillery, 1st Infantry Division, is an outstanding United States Artillery Unit with great combat ability and outstanding fire support techniques. Operating in Vietnam from July 1965 to April 1970, tested by repeated clashes with the Vietnamese Communists, the men of the 1st Battalion, 7th United States Artillery, have always set a gallant example before the unit, with their will to fight and win, their acceptance of every sacrifice together with their appreciation of methods of troop maneuver and modern fire techniques for use against the enemy. The 1st Battalion, 7th United States Artillery, 1st Infantry Division, successively and outstandingly defeated several units of the Communist aggressors, at the same time creating favorable conditions for Infantry to clear out enemy rear bases and barracks in secret zones within the area of tactical responsibility of the 1st United States Infantry Division. In particular, in September 1969, during Operation 'TOAN THANG' (Phase III), the 1st Battalion, 7th United States Artillery, was moved to encircle the enemy in PHU HOA DONG Hamlet and assist the 1st Battalion, 18th Infantry, in winding up the battle. During 8 successive days of siege, before any assaults were launched the gallant men of the 1st Battalion, 7th Artillery, fired into the enemy's hiding places, creating an intense artillery fire fence and foiling all the Communists' attempts to escape from the envelopment, leveling many of their combat fortifications and weakening their fighting potential and spirit. After that, the men of the 1st Battalion, 7th Artillery, assisted the 1st Battalion, 18th Infantry, in blitzkrieg assaults to seize the objective. As a result, the 1st Battalion, 7th Artillery, accounted for many of the enemy killed in action and a number of others buried in their trenches. During Operation 'TOAN THANG' (Phase III and IV), except for engagements with major Communist units, the batteries of the 1st Battalion, 7th Artillery, were usually dispersed throughout the operating area of the 1st Infantry Division. Military operations full of dangers and hardships never deterred the men of the 1st Battalion, 7th Artillery, from fighting. The rounds fired from their batteries inflicted many personnel casualties and much damage to the food supplies and military equipment of the Communist aggressors and paralyzed their combat potential and hopes of launching a new general offensive in the III Corps Tactical Zone, especially during the period before the 1970 Vietnamese New Year. With the above combat record and the numerous splendid victories achieved, the 1st Battalion, 7th United States Artillery, 1st Infantry Division, has materially contributed to the fight against Communist aggression in the Republic of Vietnam.

The citation reads as follows:

The 11th Infantry Brigade is an outstanding unit with a gallant fighting spirit. The men of the Brigade, have effectively supported the Republic of Vietnam Armed Forces during military operations against the Communists. In particular, during Operation 'VERNON LAKE II' conducted from 2 November 1968 to 28 February 1969, the 11th Infantry Brigade moved deep into an area of critical terrain of the 3d North Vietnamese Communist Division and Quang Ngai Province Unit Headquarters. Storms, flooding and fog were constantly an obstacle to supply and medical evacuation; however, the men of the 11th Infantry Brigade ventured to launch 34 raids against enemy strongholds with the support of armed helicopters. They continuously attacked and engaged the enemy within their base areas and supply routes. Operation 'VERNON LAKE II' drove the 3d North Vietnamese Communist Division from their strongholds and prevented enemy attacks against the provincial capital of Quang Ngai. With the above outstanding achievements, the 11th Infantry Brigade has made a substantial contribution in the fight against the Communists to preserve peace and freedom in the Republic of Vietnam.
