I--GENERAL COURTS-MARTIAL. 1. *Effective 1 July 1971*, the following persons under the jurisdiction of the Department of the Army who are subject to the Uniform Code of Military Justice are attached to the US Army Military District of Washington for all matters pertaining to the administration of military justice, including general court-martial jurisdiction, regardless of whether the installations or activities at which such persons are stationed or with which they are on duty are under the command of the Commanding Officer, US Army Military District of Washington:

a. Department of the Army personnel stationed within the geographic area of the US Army Military District of Washington and not under the command of any other officer authorized to convene general courts-martial.

b. Department of the Army Attaché personnel assigned to the US Army Element (SDW1V0AA00), Defense Attaché System and Department of the Army personnel attached to Defense attaché offices for administrative support and services.

c. Department of the Army personnel assigned to the National Aeronautics and Space Administration.

2. Section II, DA General Orders 34, 1967, is rescinded.

II--GENERAL COURTS-MARTIAL. Confirming verbal order of the Secretary of the Army of 1 July 1971, the Commanding Officer, US Army Element, Field Command, Defense Nuclear Agency, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial.

III--GENERAL COURTS-MARTIAL. Confirming verbal order of the Secretary of the Army of 28 June 1971, the Commanding Officer, Korea Support Command (Provisional), APO San Francisco 96212, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial.

IV--GENERAL COURTS-MARTIAL. Confirming verbal order of the Secretary of the Army of 1 May 1971, the Commanding Officer, 3d Brigade (Separate), 1st Cavalry Division (Airmobile) APO San Francisco 96490, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial.

V--GENERAL COURTS-MARTIAL. Confirming verbal order of the Secretary of the Army of 12 May 1971, the Commanding Officer, 31st Artillery Brigade, Air Defense Homestead Air Force Base, Florida 33030, is designated by the Secretary of the Army, pursuant to the Uniform Code of Military Justice, Article 22(a)(6), to convene general courts-martial *effective 1 June 1971*.

VI--SENIOR ROTC UNIT. So much of paragraph 2, section II, DA General Orders 4, 28 January 1971, pertaining to Princeton University, Princeton, New Jersey, as reads "30 June 1971" is amended to read "1 January 1972".

VII--SENIOR ROTC UNIT. The status of the ROTC unit at the University of Puerto Rico, Mayaguez is changed from a satellite to an independent ROTC unit.

VIII--JUNIOR ROTC UNITS. 1. *Effective 30 June 1971*, a class HS JUNIOR ROTC unit was established at Baker High School, Crestview, Florida under the provisions of AR 145-2 with training to commence September 1971.

2. *Effective 30 June 1971*, a class HS JUNIOR ROTC unit was established at Fourth High School, Boise, Idaho, under the provisions of AR 145-2 with training to commence September 1974.

3. *Effective 1 July 1971*, the class MI unit at Kentucky Military Academy was reclassified to a class HS JUNIOR unit. The name will be changed to Kentucky Academy.

4. *Effective 1 July 1971*, class HS JUNIOR ROTC units at the following institutions were disestablished :

Schreiner Institute, Kerrville, Texas

Pasco High School, Pasco, Washington

5. *Effective 1 July 1971*, a class MI JUNIOR ROTC unit at Onarga Military School, Onarga, Illinois was disestablished.
