**I. UNITED STATES ARMY CRIMINAL INVESTIGATION COMMAND (SHORT TITLE: USACIDC).**

1. *Effective 17 September 1971*, the United States Army Criminal Investigation Command is established as a major command reporting directly to Headquarters, Department of the Army.

2. *Effective 17 September 1971*, the Criminal Investigation Agency, a class II activity under the jurisdiction of the Deputy Chief of Staff for Personnel, Department of the Army, is discontinued. Concurrently, personnel and equipment are transferred from the Criminal Investigation Agency to the United States Army Criminal Investigation Command.

3. The mission of the United States Army Criminal Investigation Command is to perform and exercise centralized command, authority, direction and control of Army criminal investigative (CID) activities worldwide; provide criminal investigative support to all US Army elements on a geographic basis; perform such other criminal investigative functions as may be assigned by Headquarters, Department of the Army; and make recommendations to higher, collateral and lower echelons in regard to criminal investigative matters.

**II. TWO ROCK RANCH STATION, CALIFORNIA.** Section V, DA General Orders 29, 1971, is amended to read as follows:

TWO ROCK RANCH STATION, CALIFORNIA. *Effective 19 May 1971*, Two Rock Ranch Station, California, a class II installation under the jurisdiction of the Commanding General, United States Army Security Agency, was placed in an inactive status and concurrently discontinued as a Department of the Army installation.

**III. JUNIOR ROTC UNITS.** 1. *Effective 1 September 1971*, a class HS JUNIOR ROTC Unit was established at Dr. Martin Luther King, Jr. High School, Chicago, Illinois under the provisions of AR 145-2 with training to commence 1 September 1971.

2. *Effective 1 September 1971*, a class HS JUNIOR ROTC Unit was established at Wills High School, Smyrna, Georgia under the provisions of AR 145-2 with training to commence 1 January 1972.

3. *Effective 1 August 1971*, a class HS JUNIOR ROTC Unit at Forrestville High School, Chicago, Illinois was disestablished.

4. *Effective 15 September 1971*, the NDCC Unit at Maggie L. Walker High School, Richmond, Virginia will be disestablished.

5. *Effective 30 August 1971*, the NDCC Unit at Thomas Jefferson High School, Richmond, Virginia was converted to a class HS JUNIOR ROTC unit under the provisions of AR 145-2.
